

SITE INSPECTION REPORT

1. A proposal has been received by this office from Executive Engineer PMGSY Spl Sub Division Thathri for diversion of Forest land under Forest Conservation Act. 1980 for non-forestry purpose. The project envisages total diversion of **0.71 Hac** of forest land in the favour of Executive Engineer PMGSY Spl Sub Division Thathri for construction of road from Changa to Tawai Soti of Bhaderwah Forest Division in Union Territory of Jammu & Kashmir. The site inspection of the land involved in the proposal has been done by the Divisional Forest Officer Bhaderwah on dated 15-06-2022.
2. The requirement of the land proposed by the user agency in Col-2 Part-I is unavoidable and bare minimum required for the project.
3. On inspection of the site, it is found that land required by the User agency is forest land measuring **0.71 Hac.**
4. No Rare/Endangered/Unique species of flora and fauna in the area during the visit.
5. No protected / heritage site /defense establishment etc is located in the area.
6. Project may not effect the survival of wild animal as the project is near the human habitation.
7. No violation of the Act has been carried out by the user agency as the work for this proposal is yet to be started which shall be allowed only after clearance of the proposal by competent authority.
8. Whether site, where the forest land involved is located has been inspected by concerned Conservator of Forests (No).
9. Whether the concerned Conservator of Forests agree with the information given in Part-B and the recommendations of Divisional Forest Officer (Yes).

SPECIFIC RECOMMENDATION:-

The proposal may be accepted as per guidelines of Govt. of India under Forersts Conservation Act, 1980 as the forest land proposed for diversion is essentially required for construction of road from Changa to Tawai Soti to provide road connectivity which is a key component for rural development by promoting access to economic and social services. Submitted by Divisional Forest Officer Bhaderwah is recommended to be accepted.

In reference to above cited subject, it is submitted that an online proposal FP/JK/ROAD/149839/2021 dated 07-01-2022 was uploaded on Parivesh Portal to obtain clearance for use of 1.07 Ha of forest land from RD 04/300 to 6/00 (Length = 1700 mtr).


Further an EDS to seek clarification for proposed road alignment was raised by state Govt. dated 11-02-2023 and consequently, a joint visit by the concerned staff of Divisional Forest Officer, Bhaderwah and PMGSY Division Thathri was conducted on 13-03-2023. After the joint inspection, executive Engineer PMGSY Division Thathri was requested to process a fresh proposal for this road upto Km 6th RD 400 upto which the habitation is present.

It is submitted that permission to consider the length of the road upto 5.40 Kms only against the sanctioned length of 6.00 Kms was requested from the Administrative Department so that a fresh proposal for construction of Changa to Tawai Soti road from RD 4/300 to 05/400 involving forest area of 0.71 Ha could be uploaded.

As conveyed by the Administrative Department permission for the same stands granted and a fresh proposal for the same is being uploaded on PARIVESH portal for getting forest clearance from RD 4/300 to RD 05/400.

Hence, submitted for information and necessary action please.
