

1	As per the time line, it is observed that the proposal was originally submitted through the PARIVESH 1.0 portal and has taken approximately eight years to reach the Regional Office. The reasons for such inordinate delay in processing and forwarding of the proposal may kindly be furnished	<p>This proposal was submitted by the User Agency (UA) on the PARIVESH 1.0 portal on 30.08.2019 and was processed in the Nodal Office on 02.09.2019. Upon examination, it was found incomplete and accordingly returned to the UA on 09.10.2019. Subsequently, the UA re-submitted the incomplete proposal on 25.02.2020, which, after examination, was again returned to the UA on 18.03.2020. Thereafter, the UA re-submitted the proposal once more, and the same was examined and processed by the Nodal Office on 18.08.2020, wherein the UA was directed to submit the hard copy of the proposal.</p> <ul style="list-style-type: none">• Proposal was examined & processed at DCF & CCF Kota level. CCF Kota forwarded this proposal after filling Part-III vide letter dtd. 26.7.23 & received in Nodal Office on 7.8.23. After examination by Nodal Office EDS were raised to CCF Kota on 22.8.2023• CCF Kota replied online vide letter dtd. 7.5.24 and the same was processed by Nodal Office. Since CCF Kota had not recommended the proposal, EDS were raised by Nodal Office vide letter dtd. 29.5.24. Further clarification regarding existence of road from Chorakheri to Nayagaon via Devari and proposed route from Chorakheri to Nayagaon via Maheshpura was also sought from CCF Kota along with his SIR.• No violation report was sought by Nodal Office vide letter dtd. 10.7.24 from DCF Baran• Nodal Office vide letter dtd. 18.11.24 sought clarification from DCF Baran regarding CA scheme, NPV calculation, comments from CWLW regarding area falling in Shahbad Upreti Conservation reserve etc.

		<ul style="list-style-type: none"> • CCF Kota submitted the EDS reply vide letter dtd. 11.3.26 • Proposal was forwarded to State by Nodal Office on 15.4.26 along with recommendation. • State raised EDS dated 8.5.26 regarding new SIR and status on violation & same was replied by Nodal Office on 13.5.26. Accordingly this proposal was forwarded to IRO for kind consideration. • Based on the above facts, it is evident that the delay in forwarding this proposal to the IRO has primarily resulted from the repeated submission of the proposal in an incomplete manner and the late submission of replies to the EDS at various levels, including by the User Agency (UA). Accordingly, the delay is procedural in nature and may be condoned while considering the proposal for approval.
2	It may also be clarified as to why the proposal has not been migrated / submitted through the PARIVESH 2.0 portal	Since the proposal was submitted by the PWD in the year 2019, well before the launch of the PARIVESH 2.0 portal, it remained under process on the PARIVESH 1.0 portal. Consequently, the proposal was not migrated to the PARIVESH 2.0 portal
3	Since the proposal has been processed through the PARIVESH 1.0 portal various documents have been uploaded at different locations, making proper examination of the proposal difficult. Therefore, the State Government / Nodal Officer is requested to furnish a self-contained note containing complete details of the proposal along with final recommendations for proper appraisal of the case	The self contained note with details of documents attached on the portal are annexed.


Self-contained note
