2. The point-wise reply to the EDS dated 04.02.2026 is given under:-

1.	Gol, in Observation No. 5, has asked for submission of detailed calculation sheets for the transmission line (above ground/below ground), including length and width, number of poles, area of each pole, ROW, and minimum clearance between conductors and trees, duly authenticated by the concerned DFO. However, no such calculation sheet indicating the proposed area has been furnished.	The detail of overhead T/line including its length & width, number of poles with their area, ROW duly authenticated by the undersigned has been uploaded at Sr. No.44 against additional information of Part-I. Further, no trees are coming in the proposed T/line and the minimum distance between the conductors and the ground has been proposed 15 metres (approx).
2.	In response to Observation No. 8, it has been stated that the revised copy of the TEC would be uploaded; however, the same is missing. Further, Gol has sought justification along with documentary evidence regarding the relationship and separation between M/s Bloot Fozal Hydro Private Ltd. and Apply Valley Resorts (P) Ltd., which has not been provided.	In this regard, it is submitted that GoHP had allotted Baloot Fozal SHEP in District Kullu on 25.04.2007 to M/s Apple Valley Developers, Kullu, HP. The Techno Economic Clearance (TEC) of project was accorded by HPSEB on 09.12.2009. Thereafter, Tripartite Agreement for the change in name of firm from M/s Apple Valley Developers to M/s Baloot Fozal Hydro (P) Ltd was signed on 23.11.2010 and the Implementation Agreement (IA) of the project (4.6 MW) was signed on 23.11.2010 and the same have been uploaded at Sr.No.45 against additional information of Part-I. Further, the revised Technical Concurrence (TC) to Baloot-Fozal SHEP for 5.00 MW

		capacity accorded by DoE, HP on 18.01.2016 has been uploaded at Sr. No.39 (pages-2-9) against additional information of Part-I.
3.	The reply/justification submitted against Observation No. 9 is not in consonance with the observation of Gol and therefore requires review and revision.	It is submitted that GoHP had allotted Baloot Fozal SHEP (2.0 MW) on 25.04.2007 to M/s Apple Valley Developers, Kullu, HP and the Techno Economic Clearance (TEC) of project was accorded by HPSEB on 09.12.2009. Thereafter, Tripartite Agreement for the change in name of firm from M/s Apple Valley Developers to M/s Baloot Fozal Hydro (P) Ltd was signed on 23.11.2010 and the Implementation Agreement (IA) of the project (4.6 MW) was signed on 23.11.2010 and the same have been uploaded at Sr.No.45 against additional information of Part-I. Further, the revised Technical Concurrence (TC) to Baloot-Fozal SHEP for 5.00 MW capacity accorded by DoE, HP on 18.01.2016 has been uploaded at Sr. No.39 (pages-2-9) against additional information of Part-I.
