Site Inspection Report of The Conservator of Forests, Muzaffarpur.

The Project proposal Pertains to the Rehabilitation, Upgradation and Construction of 2 lane with paved shoulder of selected road stretches Section-1 Umgaon to Kaluahi (0.000-21.610 km-NH-227L), Section-2 Saharghat to Rahika (0.000-26.135 km- NH 227J) and Section- 3 Bindeshwar Asthan to Bheja (0.000-25.915 km – NH 527A) under Bharatmala project in Madhubani District in the state of Bihar. The project requires diversion of 32.27 ha of protected forest land for non-forestry purposes.

1. The site inspection of the selected road stretches, has been done by me on 05-08-2024 with Divisional forest officer Mithila forest division and field staff. The project director of NHAI was also present with his team. The specieswise enumerated and numbered trees along selected road stretches has been verified randomly at few places and it was found correct.
2. The project is passing through notified protected forest area of Jhanjharpur, Benipatti and Madhubani Range of Mithila forest Division. These roads are notified as Protected Forest by Environment and Forest department, Government of Bihar Vide Notification No. 190E dated 16.02.1994.
3. The total 3693 trees are creating hindrance to the project. The Tree protection plan committee Constituted at the level of Regional Chief Conservator of Forests, Muzaffarpur has decided to translocate 888 trees and felling of 2805 trees.
4. The requirement of forest land is bare minimum. The user agency has not Violated the provisions of the Forest Conservation Act, 1980.
5. There are no rare/endangered/unique species of flora & fauna in the proposed forest land for diversion.
6. There is no archeological site and defence establishment present in the proposed forest land for diversion.
