As desired, please find enclosed the desired undertaking regarding principal agreement of the department for wiliness to transfer the proposed 9 Nos. roads containing total afforestable area of 13.555 hect..

As regards the objection mentioned at Sr. No. 3 of letter under reference regarding difference of area in the area required for proposed diversion (5.33 hect.) and the area calculated by our department (5.30 hect. ), it is clarified that as per linear calculations already submitted., the actual calculation works out to 5.33 hect. (and not 5.30 hect.), which was inadvertently mentioned in the earlier communication in round figures as 5.30 hect. Actually this calculated area is 5.3304 in the DGPS map already submitted to you.

In addition, the necessary online correction has also been carried out, it is requested that a fresh meeting of REC may again be arranged soon to work out the modalities for giving effect to this proposal for stage -I and subsequently, the necessary approval for Forest clearance may please be arranged at the earliest to enable this department to proceed further accordingly for construction of this prestigious, public project due to project having been covered under C.M. Announcement.
