The transmission line handled by two Divisions of AEGCL separately. Both the divisions manages half part of the total length of the line i.e., 42.767Km. It can be seen from the above table, comparing all three alternative route, the minimum forest area is covered by Route I. Out of 1.658 Km area covered under forest land, Dhaligaon Division Handles 0.939 Km of Forest land of Bhairab PRF for which, forest clearance has been obtained.

Moreover, all the parameters such as total forest covered, name of the forest, type of forest, habitation has been mentioned clearly in the above table.

- vii. Crossings of communication lines should be minimum and should be preferably at right angles. Proximity and parallelism with telecommunication lines should be eliminated to avoid danger of induction between them.
- viii. Areas subject to flooding such as nalah should be avoided.
- ix. Restricted areas such as civil and military airfields should be avoided including aircraft landing approaches.
- x. All alignments should be easily approachable in dry and rainy seasons to enable maintenance throughout the year.
- xi. Areas that will present the problems of "Right of Way" and "Way Leave" during construction and maintenance should be avoided.
- xii. Routing of transmission lines through protected/reserved forest area should be avoided/restricted as far as possible
- xiii. Effort should be made to keep the route at a distance from mining areas.

**RECONNAISSANCE REPORT FOR THREE ALTERNATIVES ALONG WITH BEE LINE:-**

In course of our preliminary survey apart from the Bee Line with three alternative routes were considered which marked in Black, Magenta, Blue & Green have been indicated in the attached Topographical maps for final selection before detail survey of the selection route is undertaken by us. Please note that those routes indicated in the attached maps are tentative. Comparative details with respect to the above routes with their merits and demerits are indicated below for kind perusal and approval of the selected route.

**(A) BEE LINE (Marked in Black).**

From the enclosed map it may please be observed that the 'BEE' line is the straight line connecting the BTPS Sub Station and the APM Sub Station. Length of the BEE Line is about 28.80 KM. This 'BEE' route in comparison to the other investigated routes is shorter. However, the aforesaid route is not a practical proposition for the following reasons: -

- 1) BEE Line passes through near about 5km (Nadangiri R.F and Bhayrab R.F) Reserved forest land area
- 2) This line also passes through Village area near Talguri, Bangalpara, Dholmara, Sidaguri, Balapara etc.
- 3) The crossing point of NH-31 & Proposed Railway is not suitable for tower location.

- 4) BEE line crossing 132KV S/C BTPS – Dhaligaon Tr. Line two times near BTPS S/S which is not possible.
- 5) This route passes through Dalni Bill area near about 2Km, that bill is a permanent water lodged area, so there was 6 nos. Pile foundation required.
- 6) This route passes maximum altitude area, so there was benching or leg extension proposal required.

Finding the 'BEE' line route not feasible, we have explored alternative routes in close proximity to the said 'BEE' line.

**(B) FINAL ROUTE (Marked in Magenta)(Proposed).**

The Length of the final route (Proposed) is 42.767KM (approx). This route passes through the villages, Salakati, Rasalpara, Banduguri, Dholmara, Bagutamari, Shilkatari, Tamulbajan, Nankuras, Singimari, Durgamari, Bamitila, Dhuntala, Pochhagaon, salbar, Radrapara, Mechpara, Kathalguri, Naldubi, Kharbazar, Barapukhuri, Bonagaon, Chakom, Kumarkata, Barbhola, Dhadaumar, Putipara, Palital and Jogidhopa. The Line passes through unavoidable Reserve Forest Nadangiri Hilly RF & Bhairab R.F land near about 1.658Km.

**(C) ALTERNATIVE-II (Marked in Blue).**

The Length of the final route (Proposed) is 50.086KM (approx). This route passes through the villages, Salakati, Rasalpara, Banduguri, Dholgaon, Naitamara, Tilapara, Bijaygaon, Duramart, Bhadaragaon, Kujia, Bidyapur, Chengmari, Majhigaon, Ujanpara, Dholagaon, Dekarmari, Tilapara, Laidhapara, Jogipara, Barkhata, Nalbari, Saopara, Naidubi, Khuramari, Pknnapara, Kerkhabari, Uttar Kerkhabari, Simlaguri, Besimai, Haripani, Chaiantapara, Khuclamari and Jogidhopa. The Line passes through Bhumeswar Hill Reserve Forest (4.000Km approx) and Nakat Reserved forest (1.000Km. approx).

**(D) ALTERNATIVE-III (Marked in Green).**

The Length of the final route (Proposed) is 48.669KM (approx).
