



6.3.4: Habitat Improvement:

a) Water Management:

Management of water resources is an important aspect in the management of the sanctuary to make water available to the wild animals within a reasonable distance so that wild animal may not have to move outside in search of water. This will reduce animal-man conflict. A good distribution of perennial water sources will help to tide over pinch period. One waterhole per 5 sq.km area is made available.

Sources of water are well distributed but flow in most of them lasts until December. Construction of inverted bandharas interspersed with anicuts along small nalas and repair of damaged anicuts will be undertaken. Water tanks, wherever choked with sand and aquatic weeds, will be cleared and deepened so that water may be retained in them until summer months.

Strengthening of existing water holes :-

In the eastern region water holes namely Murgikonta, Ushirkonta,Komatkonta, Apakonta will be deepened. List is annexed in the Appendix-II-F. Silt deposited will be excavated and used to strengthen the embankment. Bamboo seedlings will be planted on the slope of embankment so that soil may not be dislodged.

Anicuts constructed earlier will be repaired so that they may become useful again. List has been given in the Appendix- II-G. New Anicuts constructed in Ashti, chaudampalli & chandankhedi beat.

Maintenance of water holes .:-

All the water holes will be cleared of silt, sand and debris in the month of March-April each year. This will enhance their storage capacity. Debris and silt will be used to strengthen the embankment.

Any damage to tanks, troughs etc. will be repaired regularly so that water loss is checked.

Kachha bandharas on streams and nallas will be completed by the end of November so that water can be retained for longer period in the nalla. Small water pools in the nallas will be deepened by scooping the sand and silt so that water is available even after February.

Open water holes will be cleared of litter each year in the month of March-April.

The bore wells will be checked for defects and will be got repaired immediately after monsoon . Smooth functioning of the hand pumps should be ensured by applying oil periodically. A permanent level marker will be painted in tanks to indicate water level. Proper supervision should be done to ensure that the tanks are filled regularly. To make the nallas perennial or increase the durability of water in it, all the micro-catchments of these nallas will be treated for soil and moisture conservation.

This will improve water availability in the water holes and dependence Tractor drawn tanker is used from 15 Feb.to 15 June for filling saucer(Artificial waterholes) Low cast waterholes increased so that increase availability of water in summer .List of Natural waterholes and Artificial waterholes given in appendix no.II-F,II-G &II-H.

Soil & Moisture Conservation Measures :-

Many small and big nalas form tributaries before draining into Pranhita river. In view of extreme hot weather and long pinch period, adequate soil and moisture conservation measures would be undertaken. Loose Boulder Structures, Gabian Bandhara are constructed in Nala, gullies to conserve Soil & Water.

Given the typical geology and soil composition of the area, it is proposed that inverted bandhara interspersed with anicuts will be made along the nalas. This will saturate lower subterranean strata with water first, and thereafter water may be retained on the surface.

List of these are being given in appendix-II-G..

Bamboo under planting along with planting of native fruit and fodder species is proposed in the areas where ground vegetal cover has disappeared or has reduced substantially.Since Bamboo is light demander species. Open patches should be selected for Bamboo planting weed occupied area should be considered for Bamboo plant. Bamboo will provide foraging base to herbivores and hiding cover to bigger games, while fruit and fodder species enrich forage quality. Nearly 100 ha. is proposed to be tackled each year,Bamboo plantation area protected for 2 years by chainlink fencing so that Bamboo seedings are well established. After two years chainlink fence removed and reused for other plantion details of which are being annexed in Appendix no. VI-E.Page No.154

Pollarding such trees in the meadow, leaves and shoots of which, are palatable and are eaten by wild animals is proposed. Usually leaves of the lower branches are browsed by the herbivores, while higher branches remain beyond their reach. Therefore if such medium sized trees, such as Hivar, Apta, Mehadsing etc., are pollarded at one-meter height, then their newly sprouted branches and leaves can be utilized better. This can enhance food availability for the herbivores. 10 kg. Compost, if mixed with mulched soil in and around the tree that can further boost flushing of new foliage. Pollarding over an area of 30 ha each year is proposed. This area will overlap with the area selected for habitat restoration.(vide Appendix no. VI-F)
