 - (ii)The site inspection report of DFO concerned has been uploaded against additional information details in online Part-II.
 - (iii)The NoC/Affidavit dated 13.01.2022 villagers of Dharjol and Sandoa has been uploaded against additional information details in online Part-I.
 - 3. The user agency has been uploaded of all consultation and meetings of FRC and Gram Sabha of concerned villages at para K in online Part-I.
 - 4. The DFO concerned has been submitted that the forest land proposed for CA is DPF named as OD 210.
 - The user agency has been uploaded the area proposed for diversion under Forest and non-forest land against additional information details in online Part-I.
 - 6. 0.9049 ha. non forest/private land area has also been included, the sale deed/gift deed/affidavit in favour of HPPWD by owners of private land has been uploaded against additional information details in online Part-I.
