SITE INSPECTION REPORT NOT BELOW THE RANK OF DCF

A proposal has been received by this office from PWD. Gauchar for diversion of 0.45 Ha. of Forest land under Forest Conservation Act, 1980 for non-forestry purpose. The project envisages transfer of Forest land of ~~Civil Forest~~ for Motor road of **Nauti-Chatoli to Jakhet (extension)** I have carried out the site inspection of the land required on date 28-09-2015

Upon inspection of the site, the following has come to light:

1. It is found that the land required by the user agency is a Protected Forest. The break-up of the land is as under:
