With reference to the letter 3rd cited, it is informed that for the discrepancies noticed in the proposal uploaded on-line, the following action is taken in this regard.

only and not in Other States. Hence, the question of ESZ of Chincholi Wildlife Sanctuary of Karnataka falling in Telangana State in the proposed alignment of Segment-7 does not arise.

Here it is informed that for uploading the CA land details individually for each project from a land bank of CA, there is no provision in forest clearance or e-Green watch portals. The NIC may be requested to make such provision which has already been requested. In addition to above, uploading of CA lands given combined or making provision to upload CA details separately and link it to a particular project also serves the purpose of land bank concept.

Further, as regards to uploading the details of trees enumerated in the Ministry's web portal, Sri R.K.Pathak of National Informatics Center was already requested to make provision for uploading the Excel Sheet during Work Shop conducted during November, 2015. The similar provision already exists for the projects uploaded or received prior to June, 2014. Further, the same was also requested to FSI and NIC during DSS training held during June'2016.

Mr. Pathak of National Informatics Center has promised that besides other facilities, this facility will also be provided in the online system. However, the same is yet to be provided. Hence, it is requested to make provision as early as possible, for early processing of forest clearances.
