Sub:- Proposal for improvement of existing road to Male Malleshwara Temple coming in 0.94 ha of Forest Land out of 17.03 hectares of forest land already leased to Suzlon Energy limited in Seegegudda kaval in Hassan Taluk and Hassan District.

With reference to the above subject, the Deputy Conservator of Forests, Hassan Division, Hassan submitted proposal for improvement of 0.94 ha of forest land in Seege Guddadha Kaval Reserve Forest Village old Sy no.48, (New Sy no.74) Salagame Hobli, Hassan Taluk & District in favour of the Executive Engineer, Public Works Department, Hassan.

The Deputy Conservator of Forests, Hassan Division, Hassan has inspected the proposed area on 11-01-2021 and reported as below.

The proposed project is only improvement of the existing road to Male Malleshwara Temple on 0.94 ha. area of forest land, out of 17.03 ha. land already leased to M/s. Suzlon Energy Limited in Sy. No. 74 of Seegegudda Kaval Forest area vide Lease Deed Agreement No. 03/2006-07, dated 28-04-2015 and wide Stage-II Approval GOI No. 4-KRC-1895/2006- Ban/1566, dated 17-11-2006. The required area for improvement of road is Super Imposed in the map already approved to M/s. Suzlon Energy Limited. The proposed road dimension in Sy. No. 74 of Seegegudda Kaval Forest area is 1,518 mtrs. long & 6.20 mtr. wide.

The primary User Agency M/s. Suzlon Energy Limited, Bengaluru has given written consent for re-diversion in favor Executive Engineer, Public Works

Department, Hassan without taking any payment for the same and the proposed use is compatible with primary use without hindering it. Hence the Project may be accepted, as per the request of the User Agency and the Deputy Conservator of Forests, Hassan Division, Hassan.

The Deputy Commissioner, Hassan District, Hassan had given certificate (As per Check list No:3) There is no necessity of alternative suitable non forest land for this project since the proposed road is only improvement to the existing road to Malemalleshwara swamy temple coming in 0.94 hectares of forest land out of 17.03 hectares of forest land already leased to Suzlon Energy limited in seegegudda kaval in Hassan Range, Hassan Division, Hassan District.

Spot inspection was conducted by me on 15-02-2021 in Seegegudda Kaval Reserve Forest. The result of spot inspection is recorded in PART-III. Improvement to the existing road Malemalleshwara swamy temple in 0.94 hectares of forest land out of 17.03 hectares of forest land already leased to Suzlon energy limited in Seegegudda kaval in Hassan Taluk and Hassan District may be accepted. Hence the proposal along with application and recommendation from the Deputy Conservator of Forests, Hassan Division, Hassan is submitted for kind perusal under Section (2) of Forest (Conservation) Act 1980. Required information / Documents are submitted in Appendix-I to Appendix No:18.
