I submit that, the District Forest Officer, Vizianagaram has submitted proposals in hard copies in the references 8th and 9th cited for diversion of Forest land for formation of roads (8 no.) in Vizianagaram Division in favour of Executive Engineer, PR, PIU, Vizianagaram as per the instructions of the Prl. Chief Conservator of Forests & HoFF issued in the references 1st to 7th cited above. The details are as follows:-

6	Formation of road from Kuntam road to Thummiguddi, Pachinpenta (M)	1.10
7	Formation of road from Roddavalasa to Kanakanapalli, Pachinpenta (M)	1.24

The DFO, Vizianagaram has recommended the above road proposals and uploaded the same (Part-II) in Ministries Website as the above roads are essential to the people for their connectivity and essential services like medical facilities, education, marketing of agricultural produce etc., The DFO has also reported in the Part-II, that the crown density of vegetation of the proposed area is about 0.4, for SI.no.1 to 5 road proposals and about 0.1 density for the SI.no. 6 to 8 road proposals, not falling in the National Park and no protected archaeological / heritage site is located in the area. There are (160) no. of Misc., trees and 900 Bamboos (in 2 road proposals) existing in the proposed width of the road. Further, the DFO has recommended the above mentioned proposed roads in Vizianagaram Division as the required Forest area is unavoidable and there is no loss to the local flora and fauna and to connect the interior places for facilitating conveyance to the local tribal with no disturbance to the Environment.

Further, the DFO has also reported that, the Compensatory Afforestation land was also identified at Sy.no.279 at Gottivalasa (V), Garugubilli (M) of Vizianagaram District for all the (9) road proposals pending in Vizianagaram District to an extent of 32.23 ha and the authenticated DGPS maps are also submitted along with the proposals.

The proposals with all necessary field details are uploaded in the Ministries Website by filling Part-I, II & III. The hard copies of the (8 no.) road proposals in (4) sets along with connected documents are herewith submitted as the proposals are recommended by the DFO, Vizianagaram.

This is submitted for favour of kind information and necessary action.
