Further the GOK had brought an amendment to the Karnataka minor mineral concession rules (KMMCR) 1994 in the year 2016. As a result the production of M-Sand is supported by the GOK and also supported to grant quarry leases as a captive consumption to those who have the M-Sand manufacturing units/crushers.

Coming to this project the M-Sand crusher / unit is located in the jurisdiction of Harapanahalli taluk of newly declared vijayanagara district of Karnataka. In the district of Vijayanagara and adjacent fast growing davangere district the requirement of M-Sand is very high due to the more development activites.

Our M-Sand unit is at the border of both Vijayanagara district and davangere district and very much feasible to cater the demand of the M-Sand.

There is a quarry operating as a captive consumption in the revenue land of Sy.No. 1/C of uchangidurga village, Harapanahalli taluk, Vijayanagara District, Karnataka. These quarries are very small in area and which has been reaching to Ultimate Pit Limit (UPL) since the deposit is below the surface. Further expansion of the quarry is not possible. There is no such area available except the proposed area within radius of 10kms free from monuments, wildlife sanctuaries, protected forests. As we have seen the most of the granite bearing area is located in the forest land in Vijayanagara district. [The proposed area is adjacent to the revenue land. The proposed area is not deep inside the forest land.]

Here the disturbances to the wild animals or other part of the forest land is very minimum. As I am struggling to survive my M-Sand unit as well as to fulfill the demand of M-Sand for developmental work of virayanagara & Davangere district, It becomes inevitable to apply for quarry lease in the proposed location [Sy.No. 1/A & 1/D] in the forest land. I assume that there will not be any disturbances to the rest of the forest land due to quarry operation.

The proposed area free from any public building, settlements, temples, protected monuments, Schools, Railway, National or State highways, Power line or any water bodies within the distance of 200mtrs.
