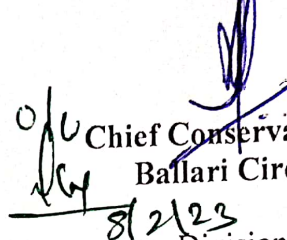

Accordingly the Deputy Conservator of Forests, Davanagere Division, Division has instructed to get the proposed area inspected and to submit the factual report about any FC violation vide (2) cited above.

The Deputy Conservator of Forests, Davanagere Division, Davanagere has obtained ground report from the subordinate officers and submitted his self contained point wise report to this office vide (3) cited above. Further, the Deputy Conservator of Forests, Davanagere Division, Davanagere while agreeing the subordinate officers report and stated that the Director of Mines and Geology Department, Bengaluru in his letter dated: 16-10-2017, 14-6-2017 and 31-6-2017 respectively as per KMMCR 1994 Amendment 2016 vide rule 31-ZC had accorded intent letter to the above user agency for granting of mining lease subject to the procurement of forest clearance.

Therefore, I am submitting herewith the copy of the letter dated:22-12-2022 of the Deputy Conservator of Forests, Davanagere Division, Davanagere for having replied all the four queries which have been invariably noticed by the Government of India, Ministry of Environment, Forests & Climate Change, Integrated Regional Office, Bengaluru vide its letter dated:17-02-2021 for taking further needful action in the matter.
