| 1    | In reply to point no.1, it is mentioned that the entire land proposed for diversion i.e. 0.3325 ha falls in only one village Mayali and village wise breakup has been corrected online accordingly. However, in the village wise breakup uploaded online at Para-B-2.3 Part-I, the land proposed for diversion has been filled as 0.00 in the column of forest land and 0.63 ha in the column of non-forest land, which is not understood. State Govt. may explain that if forest land falling in Mayali village is not required to be diverted for construction of the proposed road then why the proposal for diversion has been submitted. | User agency mentioned Mayali village in village wise breakup at section B-2.3 in Form A part I.   |
| 2    | Though in reply to point no.1 it is mentioned that entire land proposed for diversion falls in Mayali village but in the FRA certificate name of Thapla village has also been mentioned. State Govt. may provide Village Level Committee meeting proceeding under FRA for this village and also show forest land falling in this village in the village wise breakup online. And in case forest land of village Mayali only is required to be diverted then the State Govt. may revise the FRA certificate accordingly.   | User agency has mentioned that the Thapla village comes under revenue village Mayali, hence separate VLC proceedings for Thapla village is not uploaded .<br>(Note -thapla is not revenue village but a Tok under revenue village Mayali).. |
| 3    | FRA certificate and proceedings of the meeting of Sub Division Level Committee is without any date.   | Proceeding of Sub division level committee has been uploaded with date at section K (i-a) in Form A part I by user agency.  |
