



Subject: Exemption from getting the Consent to operate from the Board as per notification dated 01.04.2012 and amendment dt. 15.04.14.

Kindly refer to your letter dated 19.01.2016 received in this office on the subject noted above.

As per the documents submitted, the unit will install a banquet hall. Unit has submitted the undertaking/affidavit on which shows that no trade effluent/air emissions will be discharged except D.G. set where acoustic enclosure shall be provided. The product/process of the unit is not covered under consent management as per order's of the Chairman, HSPCB issued vide No. 10195-10218 dt. 07.03.2014 and unit falls under Green Category. Your unit does not require to seek Consent to Operate from the Board with the following conditions:-

- i) That the Unit will raise the stack height of D.G. Set as per Board's norms & shall abide by the Noise Rules, 2000 and keep the levels within permissible limits prescribed under EPA Rules, 1986.
- ii) That the unit will not discharge any trade effluent/air emission without prior permission of the Board.
- iii) That the unit will discharge domestic effluent in septic tank/soak pit.
- iv) That the unit will not change its process/product without prior permission from Pollution Control Board.
- v) That the unit will have to obtain the consent to operate from the Board, if any amendment will be made in the above said notification for covering the above mentioned product under consent management.
- vi) The validity of this exemption shall cease to exist by way of such directions/law of the State/Central Government, at any point of time, without prior notice.
- vii) The unit will obtain the permissions from other Departments as per requirement.
- viii) Unit will apply for NOC/Consent if covered under any category as per notification dt. 01.04.12/order No. 10195-10218 dt. 07.03.2014 or any amendment/order thereafter.
- ix) Unit will comply the provisions of Water Act, Air Act, EP Act, 1986, E-Waste Rules & Plastic Waste Rules whichever is applicable.
- x) Unit will submit the affidavit in this office regarding adhering and compliance of all conditions within 15 days from the date of above exemption failing which exemption so granted stand in void.

Kindly note that if the unit is found polluting at any stage or violating the provision environmental laws, the Board will be constrained to take action without any notice.
