Sir,

In inviting reference to letter No. 5-ORB513/2022- BHU dated 13.05.2022 of Dy. Inspector General of Forests (C), GoI, MoEF & CC, IRO, Bhubaneswar on the above mentioned subject, the compliance to observation is detailed below:-

**Observation:-**The User Agency has constructed building for prayer hall without prior approval from Govt. of India, MoEF & CC in contravention of FC Act, 1980.

In the recommendation, it is not clear that whether this violation is attributable or not to the User Agency. If the violation is not attributable to the User Agency then, this violation comes under which category as mentioned in as per the provision in Para-1.21 of Chapter-1 of Handbook of FC Act Guidelines, may be clearly spelt out.

In compliance to above, the DFO, Chandaka (WL) Division has stated vide his Memo No.2705 dated 21.05.2022 (Copy enclosed) that Revenue Forest land of area 0.151 ha has been allotted in favour of Central Chinmaya Mission Trust, Odisha, Bhubaneswar by the GA Department, Govt. of Odisha in the year 2001. The BDA, Bhubaneswar has given permission for construction of building by Central Chinmaya Mission Trust, Odisha vide letter No.7591/BDA dated 31.10.2003. The building of Central Chinmaya Mission Trust, Odisha had been inaugurated on 27.11.2008. The User Agency has constructed the building for prayer hall without prior approval from Govt. of India, MoEF & CC in contravention of Forest (Conservation) Act, 1980. Therefore, the violation is attributable to the User Agency.

This is for favour of information of Govt. of India, MoEF & CC, IRO, Bhubaneswar.

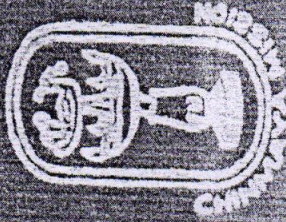
1. Construction at plinth level shall be checked by BDA. Further construction will proceed after clearance is given by BDA.
2. Water supply to the premises shall be made by topping from public water supply system in consultation with P.H.D.
3. All sewerage of the premises shall be disposed to the public sewerage line on road side in consultation with P.H.D.
4. Parking area of 2727 sqft. shall be provided in the Ground floor of Block-I (Auditorium block) and rest 612 sqft. shall be provided in the premises open to sky.
5. No waste water of the premises shall be disposed to the road side drain.
6. All storm water of the premises including roof top shall be conveyed and discharged to the rain water recharging pit to be constructed of appropriate size and specification.
7. Fire fighting installations are to be provided in the premises as per provision of National Building Code of India.
8. Compound wall shall be constructed as per the site allotted by G.A. Department.
