With regard to the proposal submitted by this office vide Ref (1) letter dated 18-06-2019 seeking Stage-I proposal under the Forest (Conservation) Act, 1980, the Government of Karnataka vide Ref (2) has raised EDS query seeking certain additional information. The same was forwarded by this office vide Ref (1) letter 31-10-2019 to you for further action.

In response, the User Agency vide Ref (3) has submitted the reply to Deputy Conservator of Forests, Kalburgi Division, who vide Ref (4) has submitted the same to you, who in turn vide Ref (4) has submitted the reply to this office.

Based on the information received from field officers, the reply to the queries raised by the Government of Karnataka is furnished as given below.

1	Justification for forest diversion	• The User Agency vide Ref (3) letter dated 27- 01-2020 has submitted a detailed note along with a map showing the alternative alignment examined by it through field officers. Copy is enclosed.
2	Alternate alignments	• The alternate route marked by User Agency as Route-2 (shown in blue colour on the map), even though shorter than the presently propose alignment does not cater to three Gram
2	examined by User Agency	Panchayats, viz., Shadipura, Kunchavaram and Venkatapur and thus there is no alternate route to cater Digital services to these three Gram Panchayats.
		• The User Agency has uploaded this letter in Additional Information Details in PART-I of the proposal on FC web portal and has also submitted the hard copy of the same through field officers.
		It is therefore, concluded that there are no alternatives to cater to all Gram Panchayats and laying of OFC being proposed along the existing road in this forest area may be considered for diversion of forest land in

This is with reference to the captioned subject and the letters referred above. Request for permission to lay Optical Fiber Cable passing through reserved forest are has been sent to your office seeking your permission to approve the route for providing FTTH connections to Gram Panchayats.

BharatNet Karnataka is the project under Digital India program where in the aim is to make the villagers, a feel of advantages of internet access. In the wake of this, in coordination with State Govt. Karnataka, BharatNet (BBNL) Karnataka has identified 6085 Gram Panchayats in Karnataka and already 6078 GPs are working. The work for 3 Gram Panchayats namely Shadipura, Kunchavaram and Venktapur in Chincholi Block of District Gulburga are pending due to Right of Way (RoW) Forest permission.

The route identified for laying cable from Chincholi to these three gram panchayat locations passes through RF area of Chincholi, Shadipura, Chindanur, Lachhmasagar and Ventkapura.

## Para-1:

BharatNet is a Turn Key project and is supposed to be completed in the time bound period. The issue of permission for RoW through these RF areas is being pursued since long. As the project needs to be completed by March 2020 as per the target set by PMO, Govt. Of India, under Digital India program

This stretch of Chincholi to Ventapura is of 37.1 KMs, of which RF area is 18.431 KMs in various stretches.

- 1. Shadipura Gram Panchyat has a population of 4566 people ,
- 2. Kunchavaram Gram Panchyat has a population of 3642 people
- 3. Venktapur Gram Panchyat has a population of 5600 people.



Thus the provision of services to these Gram Panchayats will help more than 13000 villagers, to avail Digital service facilities under BapujiSeva Kendra.

#### Para-2:

This route is selected specifically, as there is no alternate route to cater services to these 3 GPs.

**Route-1**: Marked in the diagram in pink colour is the proposed route for laying OF Cable from Chincholi to Venktapura through Shadipur and Kunchavaram. This route is caters for 3 GPS & hence it is selected.

Route-2: The other route marked in Blue colour as route-2, also passes through the stretches of Chincholi RF, Dharmasagar RF etc. and will cater for only one GP & therefore the route is not considered.

There is no other alternate route to cover all these 3 GPs without passing through Forest area, which is evident from the drawing enclosed.

Timely permission from your office is of utmost necessity as the OF laying work of more than 38 KMs is to be completed with GPON equipment installation.

The copy of the map showing the route-1 in pink colour as the proposed route and the Route-2 shown in ink blue ink, which is existing in the area but not feasible from point of locations of Gram Panchayats is enclosed for information.


