Non-Forest CA land does not comply with the guideline of MoEF & CC GOI as per Para 2.8 of their Guidelines issued dt.28.03.2019, regarding number of seedlings required to be planted in Non-Forest CA Land. Hence, the Scheme may be revised, if the site permits or provision be made for Addl. Compensatory	As per the Guidelines of MoEF & CC, Govt. of India, the purpose of compensatory afforestation (CA) is to compensate the loss of 'land by land' and 'trees by trees' and at least 1000 plants per hectare will be planted over Non Forest Government land identified for CA as per Para 2.8 of the Guidelines. To compensate the loss of 'land by land', suitable non-forest government land over an area of 15.379 ha. has been identified at village Dangajore under Lanjigarh Tahasil of Kalahandi District for taking up CA (@ 200plants/Ha) against proposed diversion of 15.265 ha. of Revenue Forest land.
