As per above cited subject the permission of road cut on Lakarnwali to Sirsa road was granted to you by the this office Memo NO. 2166 dated 02-12-2021 vide GR-No- 10004/26 dated 16-07-2009 with amount of road cut fee Rs. 2700/- and the same was paid in to treasury through Challan No.81 dt. 20-7-2009. The complete revised NOC for road cut is again issued with the following condition as per your request

1. Permission from the other deptt. if required the same may be obtained at your level.
2. Pipe must be laid at least 1.65 Mtr. below the road level, and give prior information to concerned JE incharge of Road.
3. In case of future widening of the road or any work will be carried out by the PWD B&R the same will be shifted/replaced by you at your own cost.
4. If any mis happening occurs during the road cut, this department will not be responsible for this, so the proper safety measure should be taken for traffic regulation and safety.
5. If any loss of any department such as cutting of telephone wire, water pipe line occurred then the responsibility will be rest upon you.
6. The parapets of pipe should be constructed at least 5' away from Road edge
7. If you do not follow the instruction at the time of execution of work, the NOC will be cancelled.
