With reference to your letter 3<sup>rd</sup> cited, I am to inform that in the reference 4<sup>th</sup> cited (copy enclosed), the Principal Chief Conservator of Forests & Head of Forest Force has stated that the User Agency has identified non-forest land over an extent of 1.540 ha in Sy.No. 418-P of Kommika (V), Koyyuru (M), Visakhapatnam District for CA purpose to enable the Forest Department to effectively manage the newly planted area. The Divisional Forest Officer, Narsipatnam has inspected non-forest land offered for CA purpose on 14.02.2022 and submitted CA scheme details. Accordingly, the Chief Conservator of Forests, Visakhapatnam Circle, Visakhapatnam has submitted CA scheme to an extent of 1.54 ha with a financial outlay of Rs.7.53 lakh for a period of 10 years commencing from 2022-23 to 2033-34 with 10 years maintenance in the non-forest land identified by the User Agency in Sy.No. 418-P of Kommika (V), Koyyuru (M), Visakhapatnam District for Compensatory Afforestation. The CA scheme, map, site inspection report and other related certificates are enclosed herewith.

I request you to consider above additional information and obtain and communicate the approval of Government of India, Ministry of Environment, Forest & Climate Change, under Section- 2 of Forest (Conservation) Act, 1980, for diversion of 1.54 ha. of forest land in Compt. Nos.513 & 514 of Ananthagiri RF-II, Ananthagiri Range, Visakhapatnam Division for formation of road from Nimmalapadu Bongija to Lungaparthi from 0/0 to 10/0 Km (via) Patti in favour of Executive Engineer, PR(PIU), Paderu, at an early date.
