With reference to your letter 3<sup>rd</sup> cited, I am to inform that in the reference 4<sup>th</sup> cited, the Principal Chief Conservator of Forests & Head of Forest Force has stated that the User Agency has identified non-forest land over an extent of 1.16 ha in Sy.No.279 of Gottivalasa (V), Garugubilli (M), Vizianagaram District for CA purpose to enable the Forest Department to effectively manage the newly planted area. The DFO, Vizianagaram has inspected the non-forest land identified for CA purpose on 02.11.2021 and submitted CA scheme details. The Chief Conservator of Forests, Visakhapatnam Circle, Visakhapatnam has submitted CA scheme to an extent of 1.16 ha with a financial amount of Rs.4.990 lakh for a period of 12 years commencement from 2022-23 to 2033-34 with 10 years maintenance in the non-forest land identified by the User Agency in Sy.No.279 of Gottivalasa (V), Garugubilli (M), Vizianagaram for Compensatory Afforestation. The CA scheme, map and other related certificates were uploaded online. The revised NPV rates communicated in GoI, MoEF&CC (FC-Division) File No.5-3/2011-FC(Vol-I), dt.06.01.2022 have to be applied for NPV for the subject proposal.
