I along with officer of user agency have re-inspected the site of proposed laying of Optical Fiber Cable line (OFC) pertains to M/s IDEA Cellular Limited,. Hyderabad on 13.05.2016. It is falling in Compt. No. 683 of RF Indaram in Beat Sarangapally of Mancherial Range. The proposed OFC line enters in the forest at latitude 18.93844.
