Sub: Diversion of 37.4 ha of Revenue forest land for preparation of land bank for relocation of villagers situated in Satkosia Gorge Sanctuary/ Satkosia Tiger Reserve under jurisdiction of Satkosia (WL) Division by Tahasildar, Angul Tahasil of Angul District.

In inviting reference to letter No. 5-ORC-505/2022- BHU dated 04.04.2022 of Scientist- B, GoI, moEF & CC, IRO, Bhubaneswar on the above mentioned subject, it is to inform that the point wise information received from DFO, Satkosia (WL) Division, Angul is detailed below:-

<u>Point No. 1:-</u>A certificate from District Collector to NTCA regarding non-availability of land suitable for relocation of the villages located within the Protected Area and Tiger Reserve before any proposal of relocation within the forest is approved.

In this regard, the DFO, Satkosia (WL) Division has submitted a certificate for non-availability of suitable non-forest land for relocation of the villages from Satkosia Gorge Sanctuary/Satkosia Tiger Reserve, which is enclosed as **Annexure-I**.

<u>Point No. 2:-</u> Clarification on the extent of land de-reserved/ de-notified for resettlement shall not be more than the extent vacated by the settlers in the core area.

In this regard, the DFO, Satkosia (WL) Division has clarified that the extent of land vacated by settlers amounts to 359.81 ha, while the extent of land de-reserved/ de-notified for settlement is only 37.40 ha. The joint certification on the extent of land de-reserved/ de-notified for resettlement is enclosed as **Annexure-II**.
