Subject: **Diversion of 0.5705 hectare of forest land (instead of 0.5948 hectare) in favour of Snowfoam Energy Pvt. Ltd. for the construction of Hamshu-I SHEP (2 MW) within the jurisdiction of Kullu Forest Division, Dist. Kullu, Himachal Pradesh.(OnlineProposal No. FP/HP/HYD/39463/2019).**

Sir,

Kindly refer to your office letter No. 8B/HP/01/52/FC/539 dated 03.07.2021 on the subject cited above.

2. In this context, it is, submitted that user agency has changed RoW of underground Transmission Line from 1.0 meter to 600 mmm to use minimum forest land and avoid unnecessary felling of trees. Accordingly, the user agency has revised the proposal for the diversion of 0.5705 hectare of forest land (instead of 0.5948 ha). Further, reply to the observations as raised vide your above referred communication is submitted as below:

1. Fresh Techno-Economic clearance is placed in the proposal folder at P.No. 109-117.
2. Supplementary IA is placed in the proposal folder at Page No. 52-55.
3. The power evacuation plan is placed in the revised proposal folders at Page No. 56-57.
4. The user agency has taken Row of Transmission line as 600 mm and proposal has been revised accordingly.
5. The revised CA scheme has been placed in the proposal folder at P.No. 37-48.
6. The information/document regarding river basin study is placed in the proposal folder at P.No. 58.
