- 2) It is to inform that, in the reference 1st cited, the MoEF&CC,GoI, IRO,Sub office at Vijayawada on examining the subject proposal, has requested to issue instructions to the user agency to identify equivalent non-forest land for Compensatory Afforestation purpose in lieu of forest land of an extent of 11.03 ha proposed for diversion for processing the proposal under Section 2 of Van (Sanrakshan Evam Samvardhan) Rules, 2023.

3. Determining – Size of CA (area in Ha):

The land proposed for CA is recorded as Forest in Revenue Records., However, it is neither notified forest under any act nor under the possession of forest department. Such land has to be twice the extent of diversion area for CA as per Van (Sanrakshan Evam Samvardhan) Adhiniyam rules, 2023. Hence, an area of 24.78 Ha is proposed for CA.

Site suitability of CA-NFL land :

Inspected the proposed CA land along with Sub-Divisional Forest Officer, Proddatur, Forest Range Officer, Proddatur, Deputy Executive Engineer, NH (R&B) and Concerned Section and Beat Staff. The proposed land is in Sy.Nos. 506B & 507 of Nandyalampeta Village of Mydukuru Mandal in jurisdiction of Nagasanipalli Beat of Proddatur Range. The said land is adjacent to Machupalli Forest Block and at distance of approximately 1.30 Kms from Sri Lankamalleswara Wildlife Sanctuary and Lankamala Extn RF. The proposed land is falls in the Eco-Sensitive Zone of Sri Lankamalleswara Wildlife Sanctuary.

As per revenue records (RSR), the land is recorded as "Forest", and in compliance with the Van (Sanraksham Evam Samvardhan) Adhiniyam Rules, 2023, twice the extent of the diverted area i.e., 24.78 hectares have been allocated for Compensatory Afforestation. This fertile land, previously used by farmers for seasonal and long-term crops, is suitable for plantations under the Semi-Mechanical Method (SMM) at a density of 1111 plants per hectare. The CA land has been proposed in 4 Bits viz., Bit-1 (13.18 ha), Bit-2 (7.45 ha), Bit-3 (1.82 ha), and Bit-4 (2.33 ha). An existing stream between Bit-

3 and Bit-4 is proposed to be incorporated into the CA area and to be handed over to the Forest Department for management purpose.
