SCHEME FOR "STATE VIGILANCE AND ANTI CORRUPTION BUREAU" IN THE STATE OF HIMACHAL PRADESH.

Consequent upon the unification of Vigilance and Enforcement Department into new organization named as "The State Vigilance and Anti-corruption Bureau (SVAB)", the work of the organization will now be carried out in accordance with the following scheme, in supersession of all other previous schemes formulated and circulated earlier.

1. Concept of merger.

27

The merger is not a merely an exercise in arithmetic; a totaling of the sanctioned strength and resources of two Wings. It will ensure that intrinsic and mandate of the two Wings is preserved. Equally important new organization will improve from its predecessors in term of professionalism and efficiency. This would imply an improvement in the quantity and quality of output, prosecution and conviction etc. and will also address their inherent weakness. Hence, a few structural changes have been made in the organizational structure. The staff in the new organization will be deployed by the DG/ADG(Vig.) as proposed by him vide letter No.15691 dated 16-10-2006.

2. State Vigilance Committee.

The constitution, objectives and functions of the Committee will be the same as circulated vide this Department notification No.Per(Vig.)D(5)-2/85 dated 3.4.1987 amended on 2.6.2000 and 14.6.2006. However, due to the merger of the Enforcement Department, the ADGP(Enforcement) will be deemed to have been deleted as a member of the Committee.

3. The State Vigilance and Anti-Corruption Bureau.

The State Vigilance and Anti-Corruption Bureau in the State will have following wings:-

(i) Secretariat Wing.

(ii) Investigating Wing.

(iii) Inquiring Wing.

(i).Secretariat Wing:-This Wing will be headed by the Pr.Secretary/Secretary (Home/Vig.) and the Chief Minister or any other Minister given the charge of the Vigilance as the Minister-in-Charge. The Director Vigilance will also function as exofficio Secretary. The Director of Vigilance will be overall administratively incharge of the State Vigilance and Anti-Corruption Bureau. (ii).Investigating Wing:-

(a).Investigating Unit:- The new Organization will be headed by a Police Officer of the rank of DG/ADG who will be assisted by 2 IGs/DIGs at HQ. The Investigating wing will be comprised of 12 Police Stations(Anti-Corruption Units) one at each District Headquarter and the Special Investigation Unit at the state HQ. For this

By. Superintendent of Police Vigilance Anti Gorruption Zone Shimla - 171002 purpose, the two existing Police posts of Keylong and Reckong Peo will be upgraded to be headed by Dy.S.P. Each Police Station will have separate staff to deal with anti-corruption and economic offences. The Districts of the State have been divided into three ranges instead of present two (SR and NR) by creating a new Central Range. Each range will be headed by an S.P. For administrative purposes, the 3 ranges have been placed under the charge of the 2 IGs/DIGs at Headquarter but the operational control would be based on subject matter. The SPs would send -all cases and enquiries pertaining to economic offences to one IG/DIG and those relating to anti-corruption to the other. The organizational structure will be as per Appendix-L.

(b).Prosecution/Legal Unit:- This unit will consist of Law Officers who will prosecute cases in court and tender legal advice to the I.Os., Range SPs., IGs/DIGs and DG/ADG. At HQ two Joint Directors will tender legal advice to 2 IGs/DIG. One DA and one Dy DA/ADA will look after the prosecution cases in each range. They will prosecute cases in the Court of Sessions Judge as cases in the Courts of JMICs will be prosecuted by the District APPs and tender advice to the range SPs and IOs. and will be under the administrative control of respective JDs at HQ. The organizational structure will be as per Appendix- II.
(c).Special Investigation Unit:- This unit at the State HQ will be headed by a SP, and will investigate such cases/enquiries to which priority has been assigned by the DGP/ADG or the State Government or which involve investigations in several districts/ranges or at the discretion of the Government/DGP/ADG. This unit will also investigate all such cases/enquiries entrusted to the Bureau on the direction of courts. The SIU will be a proactive Cell, also functioning as a flying squad.

(d) Technical Unit:- Technical unit will consist of officers from other departments and will render technical advice and assistance in the investigation of cases and enquiries and will be stationed at HQ under supervisory charge of SP SIU. Need based technical assistance will be obtained from a Department at any point of time. This wing will now consist of one Range officer, 1 Naib Tehsildar, 3 Junior Engineers(new posts) and 1 Accounts Officer who will look after the accounts work at HQ and also render technical need based guidance in cases and enquiries.

The Inquiring Wing of the State Vigilance and Anti-Corruption Bureau consists of the Commissioner, Departmental Enquiries, H.P. He conducts oral enquiries under CCS (CCA) Rules, 1965 against GOs/NGOs. He may also be entrusted with oral enquiries

under other disciplinary rules e.g. under AIS(Discipline and Appeal)Rules, 1969.One Public Prosecutor (DA) is permanently attached to the CDE for departmental enquiries to present the cases on behalf of the disciplinary authorities.

4. Functions/duties of the State Vigilance and Anti-Corruption Burcau.

'The State Vigilance and Anti-Corruption Bureau' will enquire into the matters under and also to investigate the cases relating to corruption and economic offences including the cases under I.P.C., Prevention of Corruption Act; 1988, H.P. Prevention of Specific Corrupt Practices Act, 1983, Essential Commodities Act Narcotics Drugs and Psychotropic Substances Act, 1985, Motor Vehicle Act, 1988, The Indian Forests Act, 1927, The Punjab Excise Act, 1914 as applicable in HP., The H.P. Forest (Sales of Timber) Act, 1968, Central Sales Tax Act, 1956, The Wild Life Protection Act, 1972. The Bureau will enquire/investigate into complaints/cases against Non-Gazetted Officers at its own level but the complaints/cases against the Gazetted Officers will be enquired/investigated by it with prior approval of the Government as per provisions of para 4 of Chapter II of Vigilance Manual. Besides, the Government may assign to it other enquiries from time to time. The Bureau will furnish reports, when called for, to the Government for issuance of vigilance clearance certificates in favour of officers/officials of the respective Departments.

- 1. The ADG-cum-Director Fire Services discussed the draft of proposed Fire Service Rules with the representatives of H.P. Town and Country Planning Department, Municipal Corporation Shimla, HIMUDA, Urban Development Department, H.P. State Industrial Development Corporation, Higher Education, Prosecution and Tourism Departments. As requested in the previous meeting held in this regard on 24-05-2019, all the representatives were asked to submit their suggestion alongwith supporting instructions /documents required to be incorporated in the proposed Fire Service
- 2. It was pointed out that out of 50719 industrial units in HP, only 1379 (approx. 3%) units have obtained Fire NOC. There is a need to ensure fire safety in industrial units therefore, the Industries Deptt. must make necessary provision in their rules etc.
- 3. The TCP bye laws provide for Fire NOC/ clearance in Rule 13,14 and 67 (Appendix 3) in respect of IT park and Appendix 7 in respect of Apartments and colonies, however the same is not being implemented. The other categories of occupencies are not covered and need to be covered by TCP deptt. The site inspection reports are also being obtained selectively by MC and TCP. The Director TCP may discuss these issues with the concerned officers before the next meeting. The supporting instructions /documents related to their department were not available with the representatives of

above departments. They were requested to bring the hard copy of their existing Act Rules and to submit their suggestions in writing as per provision of their existing Acts, Rules and bye laws in the next meeting positively scheduled to be held on 01-06-2019 at 12 Noon.

- 4 The representative of Education department was advised to implement the Judgement delievered by the Hon'ble Supreme Court of India in Writ Petition(Civil) No 483 of 2004 while granting permission to Schools as out of 15615 Govt Schools and 4244 private schools, only 235 govt schools and 2011 private schools have obtained Fire NOC. Furthermore, College, Hostels, Coaching Institutions etc. are not being inspected for fire safety at present. The Education department must devise procedures for ensuring fire safety at such institutions for the safety of students and staff.
- 5. The department of HIMUDA, RERA and TCP were advised to make provision for obtaining Fire NOCs in their rules for buildings consisting of 8 or more flats, buildings for use by third party and paying guest houses etc.
- 6. The representative of Tourism department informed that they are granting permission for hotels and guest houses after inspection by their officers as per HP Tourism Trade Rule-2012. This seems to be a grey area as the Tourism Officers may not be in a position to inspect or advise on the fire prevension measures. The Tourism Dept. may specify the requirement of Fire NOC on the basis of floor area of tourist unit or units with 20 or more rooms.
- 7. Big establishment outside the TCP area such as Police Bns., technical and Medical educational institutions and hospitals also need to be evaluated for fire risk and must seek advise of fire department with regard to fire prevension.
- 8. All the departments were asked either to make provision of Fire NOC in their Rules/ Bye Laws in conformity with NBC or incorporate Fire rules for granting permission to various stakeholders.
- 9. It was decided in the meeting that the site Inspection report does not serve any purpose and must be discontinued. However, "NOC" will be required by the department on completion of construction work of building/project etc. after adoption of Life & Fire Safety measures as per NBC Part-IV by the owner/ occupier.

- 10. It was also decided in the meeting that the departments which are not covered under MC/ TCP areas may also request the Fire Services Department for suggesting the fire safety norms.
- 11. All the departmentswere requested to study the DDA bye faws, Fire Services Rule of Delhi and Orissa which have been sent to them by email for incorporating, the necessary provisions in the proposed H.P. Fire Services Rules.
- 12.It was observed that the representative from the Health department, and Technical Education department may also be called for meeting scheduled to be held on 01-06-2019 at 12 Noon.

The meeting ended with a vote of thanks to and from the chair.
