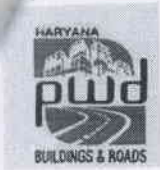

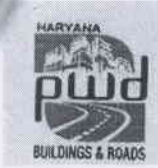

Sir,

Please refer to the above cited letter and online proposal no. FP/HR/Road//22883/2016 seeking prior approval of the Central Government for diversion of forest land for non-forestry purpose in accordance with section 2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the proposal of the State Government and approval of the REC, "in-principle" approval is hereby conveyed for diversion of 9.58 hectares of forest land for the above mentioned project subject to the following conditions:

- i) Cost of compensatory afforestation as per CA scheme may be realized from the user agency;
- ii) Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may be realized from the user agency, as per Ministry's directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008;
- iii) As per the orders of the Government of India vide letter No. 5-2/2010-CAMPA 24.06.2011, the Net Present Value (NPV) of the forest land and all other CA levies shall be deposited through web portal of Ministry of Environment, Forest and Climate Change <http://forestsclearance.nic.in> or <http://efclearance.nic.in>.

3. The following conditions shall also be complied with after the final approval is accorded:

- i) Legal status of the forest land will remain unchanged;
- ii) Efforts should be made to fell minimum number of trees and in any case, not more than 1156 trees will be removed.
- iii) The trees should be felled under strict supervision of the State Forest Department;
- iv) The CA will be carried out over 19.16 ha forest land as per the CA scheme and addl. CA scheme and the funds will be provided by the user agency. The plantation will be done within one year from the date of issue of this letter.
- v) The forest land will not be used for any other purpose than that mentioned in the proposal;
- vi) The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department, or person without approval of the Central Government;

- vii) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- viii) The user agency shall raise strip plantation on both sides and central verge of the road at the project cost as per IRC specifications with maintenance of seven to ten years;
- ix) No damage will be done to the adjoining forest land;
- x) No labour camp shall be established on the forest land;
- xi) The user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court;
- xii) The user agency shall carry out muck disposal at pre-designated sites in such a manner so as to avoid its rolling down and should be taken up as per the scheme approved by the Forest Department;
- xiii) The required soil conservation measures should be taken up by the user agency for which fund should be provided as per the current rate of works;
- xiv) The User Agency shall provide firewood preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
- xv) The boundary of the forest land being diverted shall be demarcated on ground at the project cost, using four feet high RCC pillars, each pillar inscribed with the serial number, GPS coordinates, forward and backward bearings and distance from pillar to pillar etc.;
- xvi) The User Agency shall ensure that because of this project, no damage is caused to the flora and the wildlife available in the area;
- xvii) The user agency will assist the State Government in conservation and preservation of flora and fauna of the area in accordance with the plan prepared by the Chief Wildlife Warden of the State.
- xviii) Any other condition that this Regional Office may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife;
- xix) The User agency shall submit the annual self compliance report in respect of the above conditions to the State Government and to the concerned Regional Office of the Ministry regularly;
- xx) It will be the responsibility of the State Government/User Agency to obtain all other prior approvals/clearances under all other relevant Acts/Rules/ Court's Rulings/instructions, etc., including environmental clearance, as applicable to this proposal;

4. After receipt of the compliance report on fulfillment of the conditions under para-2 above, the proposal shall be considered for the final approval under Section-2 of the Forest (Conservation) Act, 1980. The use of forest land will not be allowed till final approval is accorded and environmental clearance, if any applicable, is obtained.

Please refer to the above cited subject and letter for seeking prior approval of the Central Government for diversion of forest land for non-forestry purpose in accordance with section 2 of the Forest (Conservation) Act, 1980. Vide this office letter of even no dated 22.11.2017 in principle approval was accorded the compliance of which has been reported vide letter no. Admn-D-3-7097/3084 dated 18.12.2017.

2. After careful examination of the proposal of the State Government, approval is hereby conveyed for diversion of 9.75 hectares of forest land for the above mentioned project, subject to the following conditions:

- i) Legal status of the forest land will remain unchanged;
- ii) Minimum number of trees/plants and in any case not more than 1156 trees will be removed;
- iii) Compensatory afforestation will be carried out over 19.16 ha of degraded forest land on RF Shekhpura & RF Bassi as per proposed scheme, at a cost of Rs.1,43,06,389/- provided by the user agency;
- iv) Compensatory afforestation will be done within one year from the date of issue of final approval over the extent of land as approved, out of the funds provided by the user agency.
- v) The forest land will not be used for any other purpose than that mentioned in the proposal;
- vi) The forest land proposed to be diverted shall, under no circumstances, be transferred to any other agency, department, or person without approval of the Central Government;
- vii) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
- viii) User agency shall also submit design of providing at least two to three rows of long rotation indigenous trees, as per provisions of IRC-SP-21-2009 (*guidelines on landscaping and tree plantations*) on either side of road before starting work on forest land;
- ix) The user agency shall raise strip plantation on both sides and central verge of the road at the project cost as per IRC specifications with maintenance of seven to ten years;
- x) No damage will be done to the adjoining forest land

- xj) No labour camp shall be established on the forest land;
- xii) The trees should be felled under strict supervision of the State Forest Department;
- xiii) The user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court;
- xiv) The user agency shall carry out muck disposal at pre-designated sites in such a manner so as to avoid its rolling down and should be taken up as per the scheme approved by the Forest Department;
- xv) The required soil conservation measures should be taken up by the user agency for which fund should be provided as per the current rate of works;
- xvi) The User Agency shall provide firewood preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
- xvii) The boundary of the forest land being diverted shall be demarcated on ground at the project cost, using four feet high RCC pillars, each pillar inscribed with the serial number, DGPS coordinates, forward and backward bearings and distance from pillar to pillar etc.;
- xviii) The User Agency shall ensure that because of this project, no damage is caused to the flora and the wildlife available in the area;
- xix) The user agency will assist the State Government in conservation and preservation of flora and fauna of the area in accordance with the plan prepared by the Chief Wildlife Warden of the State.
- xx) Any other condition that this Regional Office may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife;
- xxi) The User agency shall submit the annual self compliance report in respect of the above conditions to the State Government and to the concerned Regional Office of the Ministry regularly;
- xxii) It will be the responsibility of the State Government/User Agency to obtain all other prior approvals/clearances under all other relevant Acts/Rules/ Court's Rulings/instructions, etc., including environmental clearance, as applicable to this proposal;

Please refer to the above cited letter and online proposal no. FP/HR/Road/30540/2017 seeking prior approval of the Central Government for diversion of forest land for non-forestry purpose in accordance with section 2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the proposal of the State Government and approval of the REC, "in-principle" approval is hereby conveyed for diversion of 11.01 hectares of forest land for the above mentioned project subject to the following conditions:

- i) Cost of compensatory afforestation as per CA scheme may be realized from the user agency;
 - ii) Net Present Value (NPV) of the forest land being diverted for non-forestry purpose may be realized from the user agency, as per Ministry's directions issued vide letters No. 5-3/2007-FC dated 5th February 2009 and Hon'ble Supreme Court of India's Order dated 30th October 2002, 28th March, 2008, 24th April, 2008 and 9th May 2008;
 - iii) As per the orders of the Government of India vide letter No. 5-2/2010-CAMPA 24.06.2011, the Net Present Value (NPV) of the forest land and all other CA levies shall be deposited through web portal of Ministry of Environment, Forest and Climate Change <http://forestsclearance.nic.in> or <http://efclearance.nic.in>.
 - iv) The User Agency shall ensure that no other proposal in the division, for which Stage-I has already been granted in the past, is still pending for compliance of conditions of Stage-I approval. An Undertaking to this effect that "no such proposal for compliance of conditions of Stage-I approval is pending with this division" be submitted. Compliance of the same will be mandatory for the final clearance of this proposal by this office.
3. The following conditions shall also be complied with after the final approval is accorded:
- i) Legal status of the forest land will remain unchanged;
 - ii) Efforts should be made to fell minimum number of trees and in any case, not more than 1898 trees will be removed. The trees should be felled under strict supervision of the State Forest Department;
 - iii) The CA will be carried out over 27.42 ha forest land as per the CA scheme and addl. CA scheme and the funds will be provided by the user agency. The plantation will be done within one year from the date of issue of this letter.
 - iv) The forest land will not be used for any other purpose than that mentioned in the proposal;
 - v) The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department, or person without approval of the Central Government;
 - vi) The layout plan of the proposal shall not be changed without the prior approval of the Central Government;
 - vii) The user agency shall raise strip plantation on both sides and central verge of the road at the project cost as per IRC specifications with maintenance of seven to ten years;

- viii) No damage will be done to the adjoining forest land;
- ix) No labour camp shall be established on the forest land;
- x) The user agency shall pay additional amount of NPV as and when increased on the order of Hon'ble Supreme Court;
- xi) The user agency shall carry out muck disposal at pre-designated sites as per the scheme approved by the Forest Department. The required soil conservation measures should be taken up by the user agency for which fund should be provided as per the current rate of works;
- xii) The User Agency shall provide firewood preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
- xiii) The user agency will assist the State Government in conservation and preservation of flora and fauna of the area in accordance with the plan prepared by the Chief Wildlife Warden of the State.
- xiv) Any other condition that this Regional Office may stipulate, from time to time, in the interest of conservation, protection and development of forests & wildlife;
- xv) The User agency shall submit the annual self compliance report in respect of the above conditions to the State Government and to the concerned Regional Office of the Ministry regularly;
- xvi) It will be the responsibility of the State Government/User Agency to obtain all other prior approvals/clearances under all other relevant Acts/Rules/ Court's Rulings/instructions, etc., including environmental clearance, as applicable to this proposal;

4. After receipt of the compliance report on fulfillment of the conditions under para-2 above, the proposal shall be considered for the final approval under Section-2 of the Forest (Conservation) Act, 1980. The use of forest land will not be allowed till final approval is accorded and environmental clearance, if any applicable, is obtained.

महोदय,

कृपया उपर्युक्त विषय में संदर्भित पत्र एवं ऑनलाइन प्रपोजल नंबर FP/HR/Road/30540/2017 का अवलोकन करें जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा-2 के अधीन अनुमति मांगी गई है। प्रस्ताव में इस कार्यालय के सम संख्यक पत्र संख्या दिनांक 06.06.2018 द्वारा सैधान्तिक स्वीकृति प्रदान की गई थी, जिस की अनुपालना नोडल आफिसर एवं वन संरक्षक के पत्र संख्या प्रशा-डी-तीन-8356/1204 दिनांक 21.06.2018 और प्रशा-डी-तीन-8356/1656 दिनांक 02.08.2018 द्वारा प्राप्त होने के उपरांत केन्द्र सरकार उपर्युक्त विषय हेतु 11.01 हेक्टेयर वन भूमि के उपयोग के लिए स्वीकृति निम्नलिखित शर्तों को पूरी करने पर प्रदान करती है।

- वन भूमि की वित्थिक परिस्थिति बदली नहीं जाएगी।
- कम से कम वृक्ष / पौधे काटे जायेंगे। काटे जाने वाले पौधों की संख्या 1898 और पौधों की संख्या 2700 से अधिक नहीं होगी।
- प्रतिपूर्ति पौधारोपण प्रस्ताव के अनुसार Kambala beat (Trilok pur Block) and Tarun beat (Bhud Block) में प्रयोक्ता एजेंसी से प्राप्त 1,64,41,894/- रुपये (Rs. One crore sixty four lakh forty one thousand eight hundred ninety four only) की राशि से 22.02 हेक्टेयर वन क्षेत्र में पौधे लगाकर किया जायेगा।
- अतिरिक्त प्रतिपूर्ति पौधारोपण प्रस्ताव के अनुसार Kambala beat (Trilok pur Block) and Tarun beat (Bhud Block) में प्रयोक्ता एजेंसी से प्राप्त 36,65,520/- रुपये (Rs. Thirty six lakh sixty five thousand five hundred twenty only) की राशि से 5.4 हेक्टेयर वन क्षेत्र में पौधे लगाकर किया जायेगा।
- प्रतिपूर्ति पौधारोपण इस पत्र के जारी होने की तिथि से एक वर्ष के अन्दर ही जाना चाहिए। Normally 1000 saplings will be planted per ha. In case these saplings can not be planted in the DFL identified for CA, the balance seedlings will be planted in any RFPF as per prescription of working plan. The State Government will intimate names of the RFPFs in which the balance seedlings will be planted.
- वन भूमि का प्रयोग प्रस्ताव में दर्शाये गये उद्देश्य के अलावा किसी अन्य उद्देश्य के लिए नहीं किया जायेगा।
- जब कभी भी NPV की राशि बढ़ाई जायेगी तो उस बढी हुई NPV की राशि को जमा करने के लिए प्रयत्न एजेंसी बाध्य होगी।
- साथ लगे वन और वन भूमि को किसी तरह का कोई नुकसान नहीं पहुंचाया जायेगा और साथ लगे हुए वन और वन भूमि को बचाने के लिये सभी प्रयत्न किये जायेंगे।

- ix. स्थानान्तरण के लिए प्रस्तावित वन भूमि को केंद्रीय सरकार की पूर्व अनुमति के बिना किसी भी परिस्थिति में किसी अन्य एजेंसी, विभाग या व्यक्ति विशेष को हस्तांतरित नहीं किया जायेगा।
- x. केन्द्रीय सरकार की अनुमति के बिना प्रस्ताव की ले आउट प्लान को बदला नहीं जायेगा।
- xi. वन भूमि पर किसी भी प्रकार का कोई श्रमिक शिविर नहीं लगाया जायेगा।
- xii. प्रयोक्ता एजेंसी द्वारा बांछित भूमि संरक्षण पैमाने उपयोग किये जायेंगे, जिसके लिए प्रयोक्ता एजेंसी द्वारा वर्तमान दरों पर धनराशि उपलब्ध करायी जायेगी।
- xiii. प्रयोक्ता एजेंसी द्वारा श्रमिकों तथा कार्यस्थल पर कार्यरत स्टाफ को अधिमानतः वैकल्पिक इंधन उपलब्ध करायेगी, ताकि साथ लगते वन क्षेत्र को किसी प्रकार के नुकसान तथा दबाव से बचाया जा सके।
- xiv. यदि आवश्यक हो तो प्रयोक्ता एजेंसी पर्यावरण (सुरक्षा) अधिनियम 1986, के अनुसार पर्यावरण अनुमति प्राप्त करेगी।
- xv. स्थानांतरित वन भूमि की सीमायें प्रयोक्ता एजेंसी के खर्च पर 4 फीट ऊँचे सीमेंट के खम्बों द्वारा चिह्नित की जाएगी। प्रत्येक खम्बे पर क्रम संख्या, डी०जी०पी०एस०निर्देशांक तथा एक खम्बे से दूसरे खम्बे की दूरी आगे तथा पीछे लिखी जायेगी।
- xvi. कूड़ा कर्कट निपटान वन विभाग द्वारा जारी योजना के अनुसार किया जायेगा।
- xvii. अन्य कोई भी शर्त इस क्षेत्रीय कार्यालय द्वारा वन तथा वन्य जीव का संरक्षण, सुरक्षा तथा विकास के लिए समय - समय पर लगाई जा सकती है।
- xviii. यदि कोई अन्य संबंधित अधिनियम/अनुच्छेद/नियम/न्यायालय आदेश/अनुदेश आदि इस प्रस्ताव पर लागू होते हैं तो उनके अधीन जरूरी अनुमति लेना प्रयोक्ता एजेंसी व राज्य सरकार की जिम्मेवारी होगी।

3. मंत्रालय इस मवीकृति को स्थगित/रद्द कर सकता है यदि उपरोक्त शर्तों में से किसी भी शर्त का कार्यान्वयन सन्तोषप्रद नहीं है। राज्य सरकार वन विभाग के माध्यम से इन शर्तों का पालन सुनिश्चित करेगी।
