

1.	In reply to point no. 9, the number of trees at FRL, FRL - 2 m and FRL - 4 m still mentioned as 16, 216 and NIL respectively which does not appear correct. State Government may make necessary correction.	Corrections have been made as per instruction given and total no. of trees mentioned are 232 at para 4(ii) part II.
2.	In reply to point no. 11, area of muck disposal yards (0.08 ha) given in B-2.4 does not match with the area given in MDP (0.06 ha). State Government may clarify this discrepancy.	Correction has been done in form A part I.
3.	In reply to EDS point no. 13, it is mentioned that 5.00 ha area (in place of 5.00 ha MDF in the earlier selected CA area) has been selected in degraded RF land i.e. Chandikaghat Comptt. No. 08 in Gangolihat Range. State Government may upload the CA estimate, KML file in CA, geo-referenced map and SoI toposheet as submitted with the reply may be uploaded at para-13 of Part-II.	Necessary documents has been uploaded by office of the DFO-Pithoragarh at para-13 of Part-II.
4.	In view of point No. 04 above, State govt. is required to revise the CA estimate submitted earlier for 18.794 ha (9.397 x 2 = 18.794) to 13.794 ha and submit the patch-wise estimate.	Revised CA estimate for 13.794 and 5 ha have been uploaded along with KML file, Geo-referenced Map and Topo sheet at Part II.
5.	In reply to EDS point No. 14, it is mentioned that the TEC and IA are not required in the instant case. The state Govt. may provide the copy of the corresponding rules/guidelines	As per guidelines of Central Electricity Authority, a project having capital expenditure less than Rs. 1000.00 Crores does not require concurrence (TEC) from CEA. DPR of the project had already been approved by the board of UJVNL, which is competent authority in the state for approval of DPRs of hydro electric projects. Guideline has been uploaded in part I as additional information.
