In inviting a reference to the above cited subject, it is to inform that the DFO, Rayagada Forest Division vide his Memo No.3243 dt 07.08.2023 (copy enclosed) has submitted the clarification on the observation pointed out by Govt. of Odisha, FE & CC Department vide their Letter No.FE-DIV-FLD-0064-2023-16044/FE&CC dt 01.08.2023.

The DFO clarified that during his site inspection and record verification he revealed that the area 0.992 ha (Plot No. 158 & 170) out of 1.148 ha of village Anajodi are included in DLC forest land which is Patra Jungle Kissam. The plot wise DLC forest land and Revenue forest land is furnish below.
