

#### ORDER:-

In the reference 1<sup>st</sup> and 7<sup>th</sup> read above, the Superintending Engineer, Panchayat Raj Circle, Visakhapatnam has informed that an extent of 98.65 hectares of CA land is required for various road works sanctioned in RCPL WE Grant / PMGSY / AIIB / PIU works in Agency areas which have been fallen under Reserve Forest land.

The Superintending Engineer, Panchayat Raj Circle, Visakhapatnam further informed that as per Forest (Conservation Act), 1980, CA land is required for diversion of forest land and requested to identify and demarcate CA land and process alienation proposals and also requested to issue necessary instructions to the concerned Tahsildars to handover advance possession of land to the Forest Department.

In the reference 3<sup>rd</sup> read above, the Revenue Divisional Officer, Paderu reported that the Tahsildar Koyyuru has identified Government land to an extent of Ac.66.94cts (27.09 Hectares) in Survey No.418/Part in Kommika Village and Grama Panchayat of Koyyuru Mandal. The said land is classified as "Konda Poramboke". Further reported that the Tahsildar Koyyuru has inspected the proposed land along with D.E.Panchayat Raj, Mandal Surveyor, Koyyuru, Mandal Revenue Inspector and VRO concerned. During the enquiry of the Tahsildar Koyyuru it is revealed that the proposed land was not occupied by anybody and D-Pattas were not issued to anybody and further requested to issue necessary orders in the matter.

In the reference 6<sup>th</sup> read above, the Divisional Forest Officer, Narsipatnam has submitted his feasibility report stating that, survey has been conducted over the proposed CA lands admeasuring an extent of Ac.66.94cts (27.09ha) situated in Sy.No.418P of Kommika Village and Panchayat of Koyyuru Mandal and prepared DGPS maps to an extent of 25.52 Ha. of Government land (Konda Poramboke) and the same was also authenticated by the Prl. Chief Conservator of Forests, Guntur. The details are as follows:-

The Divisional Forest Officer, Narsipatnam further reported that, the forest range officer, K.D.Peta along with his staff has inspected the proposed CA land on 24.11.2021. The proposed area is covered with thick vegetation. However gap plantation and SMC works may be proposed. The proposed area starts from the middle of the hill and continues till the hillock and few encroachments noticed at the foot hill. The proposed CA area is adjacent to Bodanapalli Reserve Forest of Kakinada Forest Division of East Godavari District. Finally stated that the above proposed CA land to an extent of Hectares 25.52 is suitable for Compensatory Afforestation and requested to issue necessary instructions to the concerned revenue Officials to hand over the CA land to the Forest Department under proper Mutation and necessary entries in the revenue records.

In view of the above, the Tahsildar Koyyuru is hereby directed to handover the advance possession of the land measuring an extent of Hectares 25.52 in Sy.No.418-P of Kommika Village of Koyyuru Mandal to the Forest Department in lieu of Compensatory Afforestation pending finalization of regular alienation proposals.

The Divisional Forest Officer, Narsipatnam is requested to take over the advance possession of the land measuring an extent of Hec. 25.52 of Kommika Village of Koyyuru Mandal from the Tahsildar Koyyuru.

The Sub Collector, Paderu is requested to monitor the entire process of handing over of advance possession to the Divisional Forest Officer, Narsipatnam and report strict compliance.
