1	Provide the details/documents for temporary quarry permission issued to User Agency to carry out the works related to quarrying and its approach road.	The copies of available temporary quarry permission issued to User Agency for removal of boulders is enclosed herewith and in quarrying permission not mentioned about approach road. But in Deputy Conservator of Forests, Karwar Division, Karwar letter dated: 23-12-1994 mentioned that proposed quarry is old and approached road is existed.
2	Period of non-forestry activity for the above mentioned purpose vide using temporary quarry permission need to specified (from the date of commencement till halt)	As per available copies of temporary quarry permission temporary quarry operated by obtaining temporary permission period as under 1) From dated: 12-02-1992 to 45 days (DCF, Karwar letter) 2) From 30-12-1994 to 28-02-1995 (CFKC., letter)
3	Reasons for carrying out the on forestry activity in the proposed forest land without obtaining FC as per F (C) A, 1980.	The temporary quarry operated by temporary quarrying permission about last 25 years. The reason for proposed forest land operated for non forestry activities without obtaining FC Act, 1980 can't be explained at this stage.
