Kindly refer to the Govt. of India Sub Office Shimla, (Regional Office Chandigarh) Ministry of Environment, Forest and Climate Change CGO Complex, Shivalik Khand, Longwood HP Shimla office letter No. 8B/HP/227643 dated 12.01.2024 addressed to Addl. Chief Secretary (Forests) to Govt. of HP and endorsement thereof made to this office alongwith others concerned on the subject cited above.

2. The point wise reply with regard to the observations raised vide above referred to communication is submitted here as under in an annotated manner for favour of information taking further necessary action at your end please:-

Sr. No.	Observations	Reply
1	The cases involve regularization of encroachment and violation of FCA and since the road cannot be constructed without having physical and financial sanction of the competent authority, therefore State Govt. is required to take legal action against the officials responsible for issuing physical/financial sanction under Section 3A and 3B of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 2023 and submit action	In this regard it is submitted that as has already been reported by this office that Gani to Surandhi nalla Bridle path repair work has been done by the Forest Department during 2015-16 and 2016-17 under 2406-01-07-01 Soon Maintenance/repair of building/road and path under NPV Scheme and Rs. 4.0 lakh have been incurred for the repair of aforementioned bridle path (copy of the sanction is enclosed herewith for ready reference). So far as the question with regard to physical and financial sanction of the competent authority is concerned, the undersigned is competent for purchase/procurement of material etc. for execution of all works funded by State Govt. up to 10.0 lakh (copy enclosed). Hence, no legal action is required to be taken against the officials under Section 3A and 3B of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 2023.

2	The State Government is required to examine the role of forest officials and their failures in not getting the work stopped and taking action taken in time and letting the violation go. Action in this regard needs to be submitted.	In this regard it is reported that the Forest Department has repaired the above bridle path only from the forestry point of view i.e. patrolling and protection of forests as well as forest fire and other happenings i.e. smuggling, theft of timber etc. As per the sanction received from the competent authority this road is to be constructed from Gani to Bhurni Nala in the public interest and HPPWD had made a survey of this road. The HPPWD authorities has explored this alignment for the construction of this road as per the sanction received from the Govt. of HP. So far as the question of role of forest officials and their failure in not getting the work stopped and taking action in time is concerned it is submitted that this bridle path has only been repaired by the Forest Department from forestry point of view. As such no violation occurred for the repair of this Bridle path.

In view of the above facts it is therefore, requested that the reply as narrated above may please be considered and approval for the aforementioned proposal may kindly be obtained from the competent authority and conveyed to this office please.



2. It is informed to all concerned that the HP State CAMPA – Steering Committee, in its 6<sup>th</sup> meeting held on 01.06.2011, has approved following delegation of powers to the Forest Officers under State CAMPA for the purchase/procurement of Material etc. for the execution of all works funded by HP State

3. The above delegation of powers is subject to the following conditions:-

i) That the prior approval of the Competent Authority [HP State CAMPA Steering Committee], for the implementation of APOs and execution of works under CAT Plans, CA, NPV & Wild Life Schemes etc. funded by State CAMPA, has been obtained.

ii) That all expenditure will be incurred as per the availability of funds.

4. These powers shall be applicable with immediate effect.

The Steering Committee, in its above-said meeting, has also approved and agreed in principle that henceforth, all the powers, as would be revised/notified and delegated to the Forest Officers, by the GoHP from time to time, will automatically be applicable to all the works being funded by the HP State CAMPA. The Forest Officers may, therefore, exercise their powers for the execution of all works under State CAMPA accordingly.
