District Kangra within the Jurisdiction of HPPWD Kangra Division. The proposed road falls in Mohal Chakban Rajiana and Mohal Gujrehra in Tehsil Kangra, District Kangra (H.P.). This road will connect the people residing in village Gujrehra with direct road connectivity. The proposed road has total length of 1341 m comprising of 693 m in Forest Land, 626 m falls in Govt. Land and 22 m falls in Private Land. The proposal requires 0.8048 ha of total land comprising of 0.4156 ha of Forest Land, 0.3757 ha of Govt. Land and 0.0135 ha of private land. The road is already constructed in Violation of Forest (Conservation) Act. 1980 and proposal is prepared for regularization of violation.

Moreover the area to be connected with road connectivity is surrounded by forest land so there is no other alternative to avoid the forest land proposed for diversion.
