उपरोक्त विषय के सम्बन्ध में आपको वन संरक्षण अधिनियम 1980 के तहत प्रस्ताव पांच प्रतियों में आगामी आवश्यक कार्यवाही हेतु संलग्न भेजा जाता है। आपको अवगत करवाया जाता है कि उक्त प्रस्ताव में 0.79 है० वन भूमि प्रभावित होगी। 13 वृक्ष तथा शून्य पौधे बाधक है। यूजर एजैन्सी द्वारा राशी जमा नहीं करवाई गई है। राशी जमा करवाने हेतु अण्डर टेंकिंग दी गई है। यूजर एजैन्सी से प्राप्त राशी से क्षतिपूर्ति पौधारोपण गांव पाली जिला हिसार में भारत सरकार की स्वीकृति उपरान्त करवाया जायेगा। मौके पर यूजर एजैन्सी ने एफ०सी०ए० 1980 के नियमों की कोई उल्लंघना नहीं की है। उक्त प्रस्ताव की पौधारोपण स्कीम निम्न प्रकार से प्रस्तावित है।
