- 1. The pointwise reply of observations as raised by Govt. of India Ministry of Environment Forest and Climate Change Regional Office Shimla vide his letter under reference is given as under:
 - 1. The user agency has submitted that the detail in Part-I, A-3 (XVII) does not match with the authorization as the detail given in Part-A2 (Engineer-in-Chief Nirman Bhawan) match with the same as the A2 has authorized A3 (Executive Engineer) for preparation of Foerst case on behalf of State.
 - Administrative Approval for the construction of subject captioned road is submitted by user agency and enclosed herewith.
 - 3. Brief Note of the project has been uploaded under additional information by user agency in online Part-I.
 - 4. The final alignment and all alternate alignment explored have been marked on the KML file and SoI Toposheet in distinct colours and uploaded on the portal accordingly by user agency.
 - 5. In this regard, user agency has submitted that all prospective/ possible measures have been adopted which are essential to improve the grade of the road and accordingly the possibility of rectification of alignment from the desired points is not admissible.
 - 6. In this regard, R.O. Kangoo submitted that that road alignment in KML file is passing through agriculture land and this land is a private land. There is no encroachment found on forest land. Hence, necessary record i.e. Nakal Jamabandi and gift deed is enclosed herewith.
