Kindly refer to Govt. of India Integrated Regional Office MoEF & CC Complex, Shivalik Khand, Longwood Shimla, HP letter/ EDS No. FC/HPB/06/69/2022 dated 15.07.2022 on the subject cited above.

2. The point wise reply of the observations raised vide above referred communication have been attended, as under:-

- The user agency has submitted that the detail in Part-I, A-3 (XVII) does not match with the authorization as the detail given in Part-A2 (Engineer – in- Chief Nirman Bhawan) match with the same as the A2 has authorized A3 (Executive Engineer) for preparation of Forest case on behalf of State.
- Administrative approval for the construction of subject captioned road is submitted by user agency and enclosed herewith.
- Brief note of the project has been uploaded under additional information by user agency in online Part-I.
- The final alignment and all alternate alignment explored have been marked on the KML file and SoI Toposheet in distinct colours and uploaded on the portal accordingly by user agency.
- 5. In this regard, user agency has submitted that all prospective / possible measures have been adopted which are essential to improve the grade of the road and accordingly the possibility of rectification of alignment from the desired points is not admissible.
- 6. In this regard, DFO Suket submitted that road alignment in KML file is passing through agriculture land and this land is a private land. There is no encroachment found on forest land. Hence, necessary record i.e. Nakal Jamabandi and gift deed is enclosed herewith.
- The user agency has submitted that there is a provision of 2 No. Slab culverts. The breakup for the same has now been shown in Part-I, B.2.4 (component wise breakup).
- 8 In this regard, it is submitted that the Soil Moisture Conservation Plan to protect the soil

As well user agency has submitted that all such areas vulnerable to erosion will be protected by providing breast walls as a mitigation measures at such location by the department.

- 9 The user agency has submitted that both the dumping sites have now been marked on the KML file and uploaded on the portal accordingly. As far the question of shifting the site to the non forest land does not arise at all as all the possibility for the same have already been checked.
- 10. The certificate showing the detail of trees i.e. Nil at the dumping sites is enclosed herewith. However, the copy of same has already attached in proposal folder P. No. 35.
- 11. The muck management plan is attached herewith duly authenticated by D.F.O. Suket.
- 12. The reclamation plan of muck disposal sites is enclosed herewith.
- NPV calculation sheet/ Bills now has been revised and uploaded on online portal as per the direction by MoEF dated 06.01.2022 & enclosed herewith.
- 14. The layout plan with legend and the proper dimension of each component of the project alongwith area wise calculation is enclosed herewith duly countersigned by the competent authority.
- The abstract of trees and enumeration list have now authenticated by D.F.O. Suket and enclosed herewith.
- 16. It is submitted that Under para-2 of part-II, the Legal Status of "Other" i.e. Gair Mumkin Rasta. However it has already mentioned in Check list No. 6 of proposal folder Page No. 20.
- 17. Under para 4 (i) of the Part-II online portal as well as in hard copy of Part-II the Density of Vegetation has been reviewed and it is found correct as per area proposed for diversion.
- 18. The 1st alignment which has been finalized only according to reduction of green felling instead of 2nd and 3rd alignment.
- The Joint inspection report of the proposed area has been attached in proposal folder page No. 36-A. However, the same is enclosed herewith.
- 20. NOC/Sale Deed/Gift deeds received from the private land owners is submitted by user agency and attached herewith.
- 21. The status of proposed CA land is notified as UPF under IFA, 1927.
- 22. As per record of Suket division the geographical area of District/ Division is mentioned against column-14 in Part-II is correct as well as mentioned in hard copy page No. 10 in proposal folder.
 - 23. There is no significant impacts of the project on the species as well as on their natural habitat.
 - 24. Pertain to higher ups.
