Sir,

On the subject and references cited above, it is submitted that in the forest clearance case under Forest (Conservation) Act, 1980 in respect of proposed PMGSY road from Malhar to Marhoon, the following actions stand taken in the process of revision of the said forest clearance case:

### A. <u>Actions taken by the User Agency:</u>

- (i) The area statement has been revised by the user agency and the total forest area proposed for diversion has been reduced from 8.328 Ha to 6.938 Ha. The copy of the revised area calculation sheet has been uploaded by the user agency in FORM-A, PART-I of the proposal on PARIVESH under **"Additional Information Details"**.
- (ii) The revised Muck Disposal Plan, as per the prescribed format, has been uploaded by the user agency under "Additional Information Details" at Sr. No. 02.
- (iii) The revised Maps and KMZ files have been uploaded by the user agency on PARIVESH at Para-C of FORM-A, PART-I (i.e. Maps of Forest Land proposed to be diverted).
- (iv) The requisite revised undertakings in respect of cost of CA, NPV, and Additional NPV have been uploaded by the user agency in FORM-A, PART-I of the proposal on PARIVESH under **"Additional Information Details" at Sr. No. 03.**
- (v) The revised Layout Plan has been uploaded by the user agency in FORM-A, PART-I of the proposal on PARIVESH under "Additional Information Details" at Sr. No. 03.

#### B. Actions taken by the Divisional Forest Officer, Billawar Forest Division:

- (i) The CA plan has been revised in light of the communication No: PCCF/FCA/119-I/54-84 Dated: 03.04.2021 regarding submission of CA Plan as per the model CA Plan received from the APCCF (Nodal Officer), FCA and has been uploaded on PARIVESH accordingly.
- (ii) The Site Specific Micro Plans for Stabilization of Muck Dumping Sites by means of Biological measures have been prepared and uploaded in FORM-A, PART-II of the proposal on PARIVESH under "Additional Information Details" at Page No. 34-44
- (iii) The revised statement in respect of abstract of enumeration lists, cost of extraction of trees and NPV calculation also stand uploaded in FORM-A, PART-II of the proposal on PARIVESH under "Additional Information Details" at Page No. 17, 27 and 30 respectively.

Therefore, in light of the aforementioned facts, it is requested that the case may kindly be processed further for the grant of Forest Clearance under Forest (Conservation) Act, 1980.
