Regional Office of Ministry of Environment, Forest & Climate Change, Government of India, Nagpur vide letter under reference No.1 has sought information as per the observation of the Regional Empowered Committee as indicated in its meeting held on 28/9/2016. Accordingly, the Chief Conservator of Forest (T), Yavatmal vide letter under reference No. 3 has submitted the compliance report of the Deputy Pandharkawada letter No.DCF/Forest Proposal/WRD-HYD/CAland Conservator of Forest, 1542/2016,dt.25/10/2016 (copy enclosed). The Deputy Conservator of Forest, Pandharkawada has informed that the alternate compensatory afforestation land is not required as encroachment over the actual proposed compensatory afforesation land has now been fully removed and the photographs and site inspection report of Deputy Conservator of Forests, Pandharkawada are enclosed herewith as Annexure- I & II. As regard the provision of fencing and watchmen the Deputy Conservator of Forest, Pandharkawada has mentioned in his compliance report that it is already included in compensatory scheme and estimate submitted along with the original proposal submitted to Government of India for prior approval under FCA, 1980. He as further clarified that the Trench Cum Mount is proposed and if required, barbed wire fencing will be done. However, since no compensatory land is proposed to be changed, the Kml/shape files, DGPS maps also remain the same already submitted along with the original proposal.

In view of the above, it is requested that the Government of India may kindly be moved for approval under Section-2(ii) of the Forest (Conservation) Act-1980, at the earliest. Encl:- As above
