This is with reference to your office letter No. 8 बी/ दिल्ली/06/01/2019/613 dated 06.02.2019 regarding the subject cited above. The reply in this regard is furnished below:

2.	In Part-I User Agency has stated that forest land is proposed to be diverted for 5 years. However, since this proposal is for construction of a flyover and underpass, the area would be utilized for a larger period.	Letter regarding this from the User Agency is enclosed as Annexure-A
3.	In Part-2, DFO has mentioned the density of vegetation as 10, which appears to be wrong.	It may kindly be treated as 10% as it has been expressed in percentage. Therefore, the density of vegetation will be treated as 0.1.
4.	In the CEC report it is mentioned that the land identified for CA shall be transferred to forest department for a period of 5 years only after which it will revert back to DDA. This is against the spirit of FCA. We may write to DG, MoEF&CC informing about the Hon'ble Court's order, for further follow-up in this regard.	Hon'ble Supreme Court's order dated 26.09.2018 in Re: T.N. Godavarman Thirumulpad versus Union of India & Ors. (Copy attached as Annexure-A-1).

UPON hearing the counsel the Court made the following

O R D E R

This is an application filed by Central Public Works Department (CPWD) seeking permission for construction of Flyover and Underpass between Mahipalpur Bypass Road and Airport Road near Hanuman Mandir adjoining NH-8, New Delhi falling in Southern Ridge and Morphological Ridge area.

We had required the CEC to submit a report in this regard. The CEC has submitted its Report No.37 of 2018 on 14.09.2018.

The CEC does not have any objection to the proposal but recommends certain conditions to be imposed. These conditions are as follows:

- i) the User Agency CPWD shall deposit 5% of the project cost proportionate to the area falling within the Southern Ridge and Morphological Ridge to Ridge Management Board Fund and which under the close supervision of the Ridge Management Board will be used by the Forest Department of Delhi Government for conservation and protection of the Delhi Ridge;
- ii) the User Agency CPWD shall obtain statutory forest clearance under Section 2 of Forest (Conservation) Act, 1980 for the diversion of area falling under Southern Ridge and shall comply with all conditions that are laid down in the order to be passed for forest diversion;
- iii) the User Agency CPWD shall pay Net Present Value (NPV) as assessed by the Forest Department of Delhi Government; and
- iv) compensatory afforestation of 1000 trees shall be undertaken by

the Forest Department on the land identified for the purpose.

Learned counsel appearing on behalf of the CPWD assisted by Mr. Rajeev Sharma, Executive Engineer, CPWD says that there is no objection to the conditions and they accept the aforesaid conditions.

Under the circumstances, the application is allowed.

It is stated by Mr. Sharma that the DDA also has no objection to the conditions since both the DDA and the CPWD are working together on the same project.

The land in question will be handed over by the DDA to the Forest Department of the Government of Delhi for a period of five years and thereafter the land will revert back to the DDA. It is further made clear that even after a period of five years, the DDA will not make allotment to any other body and this land will continue to remain forest land.

The application (Report No.37 of CEC) stands disposed of on the above terms.

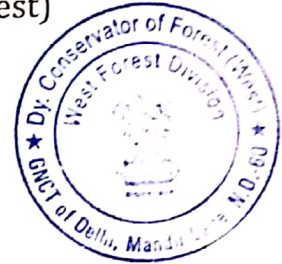



Chief Engineer (CPWD) presented the above item in the 125th EAC meeting held under the chairmanship of VC, DDA on 21.11.2017 for approval. The minutes of the above meeting was circulated vide No.EM.1(37)87/Vol.115/5468 dated 24.11.17.

The Estimate Approval Committee, DDA is pleased to accord the A/A&E/S for the above said work for an amount of Rs. 188.00 Crores (Rupees One Hundred Eighty Eight Crores Only) as total cost of the project. The fund to be released from UDF is Rs. 150.40 Crores (Rupees One Hundred Fifty Point Four Zero Crores Only) which is 80% of the total cost of the project and Rs. 37.60 Crores (Rupees Thirty Seven Point Six Zero Crores Only) to be funded by the DDA which is 20% of the total cost.

The expenditure shall be charged to Head of A/c "G.D.A." under major Code "4472" and minor Code No. "10". Necessary entry to this effect may please be made in your office record. It may be ensured that sufficient provision has been kept in RBE 2017-18 & B.E. 2018-19.

The P.E. was scrutinized in the office of Engineer Member, DDA and the proposal has been approved and cleared by Engineering & Finance Department of DDA. Accordingly the P.E. along with project report was put up to PSC as per the guidelines of UDF to sanction the fund from UDF. The project was recommended for approval by the Project Sanction Committee. Based on the recommendations of PSC, an amount of Rs. 188.00 Crores was sanctioned by MOUD, GOI vide No. 2/2/2016-DDVI dated 14.07.16. Out of total cost of project i.e. Rs. 188.00 Crores, the amount approved from UDF funding is Rs. 150.40 Crores i.e. 80% of total cost and remaining Rs. 37.60 Crores i.e. 20% is to be funded by the DDA.

This accord of A/A&E/S is subject to compliance of all the conditions as laid down in Ministry of Urban Development letter No. 2/2/2016-DDVI dated 14.07.16, 2/1/2017-DDVI dated 09.10.17 and F.1(6)Sr.A.O.W-III/UDF/2016-17/Pt. dated 13.10.17 (copies attached).

- (i) 1st installment of 20% of funds from UDF shall be released on the award of work having all clearances.
- (ii) Subsequent funds shall be released in 3 installments of 30%, 40% and 10% after the submission of utilization certificate relating to both, the previously released funds from UDF and the corresponding percentage of funding by the implementing agency from its own sources, at each stage. However, the final installment of 10% will be released only after getting the completion certificate.

- (ii) In case the rates received during the course of Tenders/Award of work are lower, the amount of UDF funding shall be reduced proportionately. Further, in case the rates received are on higher side, the UDF funding shall be limited to the sanctioned amount.
- (iv) Chief Engineer (CPWD) is suggested by EAC that a wide publicity be made for the individual work to get competent agency to carry out the work in the best possible manner.

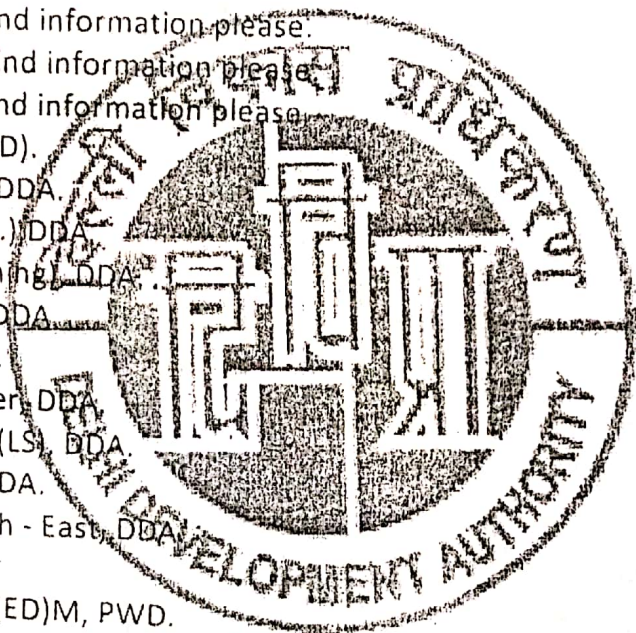

MINUTES OF 1st MEETING

SUB: To discuss the progress of decongestion projects in Delhi being funded under Urban Development Fund (UDF).

A meeting was convened on 08.12.17 (Friday) at 03:00 PM under the Chairmanship of Chief Engineer (HQ) to discuss the progress of decongestion projects in Delhi being funded under Urban Development Fund (UDF) on the direction issued from Hon'ble Lt. Governor, Delhi. List of participant is attached as Annexure-A.

Following projects were discussed:-

1. Construction of Flyover Underpass between Northern Mahipalpur Bypass Road and Airport Road Near Hans Mahavan, New Delhi (Project Cost : Rs. 188.00 Crore. Approved UDF Funding : Rs. 150.40 Crore). Out of total project cost of Rs. 188 Crore, 20% i.e. Rs. 37.68 Crore is to be funded by DDA. Chief Engineer (CPWD) demanded that for the process of inviting tender for approvals, CPWD need funds from the DDA part, whereas in the terms and conditions of MOUD, 1st installment of 20% of funds from UDF shall be released on the award of work having all clearances. It was suggested that demand for release of initial expenditure from DDA to be submitted to Chief Accounts Office DDA.

In respect of NOC and traffic sign, a joint inspection of officers of CPWD, Planning Department of DDA and Transport officials of DDA has been carried out. The report has to be submitted by Planning/Land Management Wing of DDA.

Asstt. Director (Planning) UTTIPEC informed that in the meeting of working group of UTTIPEC held on 23.11.17 and the proposal to be put up in the public domain for one month and after receiving comments, the case would be put up to governing body of UTTIPEC in the first week of January 2018.

2. Construction of Flyover-cum-ROB on UER-I at Narela (Project Cost : 437.21 Crore Approved UDF Funding : Rs. 34.97 Crore). The Technical Bid and Financial Bid opened and shall be put up for approval of WAB.

3. Construction of Skywalk and FOB at the Junction of Sikandra Road, Mathura Road, Tilak Marg and Bahadur Shah Zafar Marg at 'W' Point and new Hans Bhavan (Project Cost : Rs. 54.34 Crore Approved UDF Funding : Rs. 43.47 Crore) – Chief Project Manager (PWD) informed that work has been awarded and fund as 20% of the project cost to be released as per the MOUD terms and conditions. Action to be taken by Chief Accounts Officer/Finance Wing.

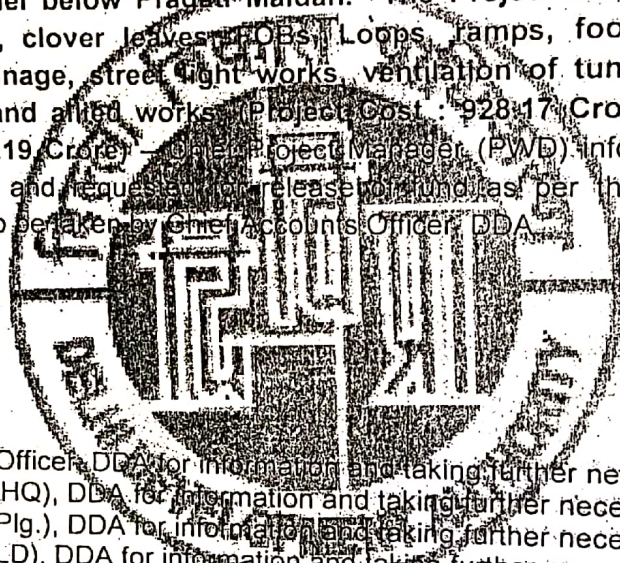
4. Road Corridor improvement of Ring Road from ISBT, Kashmere Gate to Salimgarh Bypass including construction of up-ramp for U-turn to join with existing elevated loop at ISBT Kashmere Gate and widening of road by shifting entry/exit of existing subway near Nigam Bodh Ghat (Project Cost : Rs. 18.68 Crore Approved UDF

Funding : Rs 14.94 Crore) - Chief Project Manager. (CPWD) informed that Traffic Police Department has raised certain observations sent through UTTIPEC. Chief Project Manager (CPWD) will hold the meeting with Director (UTTIPEC) to resolve the issue.

5. Construction of Grade Separator at Rani Jhansi Road (Project Cost : Rs. 200 Crore Approved UDF Funding : Rs. 85 Crore) - Chief Engineer (North DMC) informed that the 85% of work has been completed and North DMC has been released the fund as Rs. 7.98 Crore only which is less than 20% of the project cost approved for UDF. Chief Engineer (North DMC) informed that a request along with documents have been sent to Chief Accounts Officer, DDA for release of fund. Action is to be taken by Chief Accounts Officer, DDA for release of fund.

6. Integrated Transit Corridor Development along Mathura Road, Bhairon Marg, Mahatma Gandhi Marg and connecting Mathura Road to Mahatma Gandhi Marg via Underground Tunnel below Pragati Maidan. MINUTES OF THE 55th UTTIPEC GOVERNING BODY MEETING HELD ON 11.01.2018 at 03.00 P.M. UNDER THE CHAIRMANSHIP OF THE HON'BLE Lt. GOVERNOR OF DELHI.

The 55th UTTIPEC Governing Body (G.B.) meeting was held on 11.01.2018 at 3.00 P.M. at Raj Niwas under the Chairmanship of the Hon'ble Lt. Governor of Delhi. The detailed agenda items for discussion containing brief background and proposal of each project recommended by Working Groups and the Minutes of 54th UTTIPEC G.B. meeting held on 22.06.2017 were circulated to members in advance. The list of members and participants, who attended this meeting, is enclosed (Annexure 'X').

Member Secretary, UTTIPEC, welcomed Hon'ble Lt. Governor / Chairman, UTTIPEC, Vice Chairman, DDA, other members and special invitees of the 55th UTTIPEC G.B. meeting.

1. Confirmation of minutes of the 54th meeting of Governing Body of UTTIPEC held on 22.06.2017.

The Minutes of the 54th UTTIPEC G.B. meeting were circulated. Observation received from Delhi Traffic Police was discussed in detail during the 55th G.B. Meeting. Accordingly, Minutes of 54th UTTIPEC G.B. meeting circulated on 31.07.2017 were confirmed.

2. Presentation on the Status of the projects approved by G.B. Meetings during 2013 to 2017 by the road owning / implementing agencies (PWD /DMRC/MCDs /DDA/ NBCC/ NDMC).

Compiled status of the projects approved by G.B. Meetings during 2013 to 2017 (during 41st to 54th GB Meeting) was presented by UTTIPEC in the 55th G.B. meeting.

The G. B. expressed concern over the slow progress on the implementation of proposals approved by the UTTIPEC Governing Body. Further, it was desired that VC, DDA may review the status of the projects approved by UTTIPEC G.B. meetings during the last 5 years (41st to 54th GB Meeting).

Validity of the proposal needs to be specified at the time of approval of the project by UTTIPEC. Validity period of such approval shall be 1.2 times of estimated completion time proposed by the project proponent. After the expiry of the validity

period, the road owning agency /project proponent has to approach UTTIPEC for re-validation of the project.

Action: UTTIPEC

During the discussion on the status of MMI (Multi Modal Integration) of Ph-III metro stations, Engineer-in-Chief, PWD mentioned that the conceptual plans of MMI proposals were prepared by consultants engaged by UTTIPEC and the same were forwarded to PWD/DMRC for preparing detailed plans for implementation. Thus to avoid duplication of work in respect to detailed plans, it was decided that the same consultants may be engaged by UTTIPEC for the preparation of detailed MMI plans. PWD agreed to fund the engagement of consultants for preparation of detailed MMI plans for Ph-III Metro Stations.

It was informed that the Kalindi Bypass project is hanging fire for lack of NOC from U.P. Government, Hon'ble Lt. Governor directed Pr. Secretary (PWD), GNCTD to write a letter to U.P. Government for expediting the NOC.

3.1 Improvement of three intersections on Aurobindo Marg (Aurobindo Chowk to Andheria Mor)

NDMC conveyed during the meeting that the proposal required minor modification in the road geometry and same will be completed within fortnight.

Decision of the Governing Body:



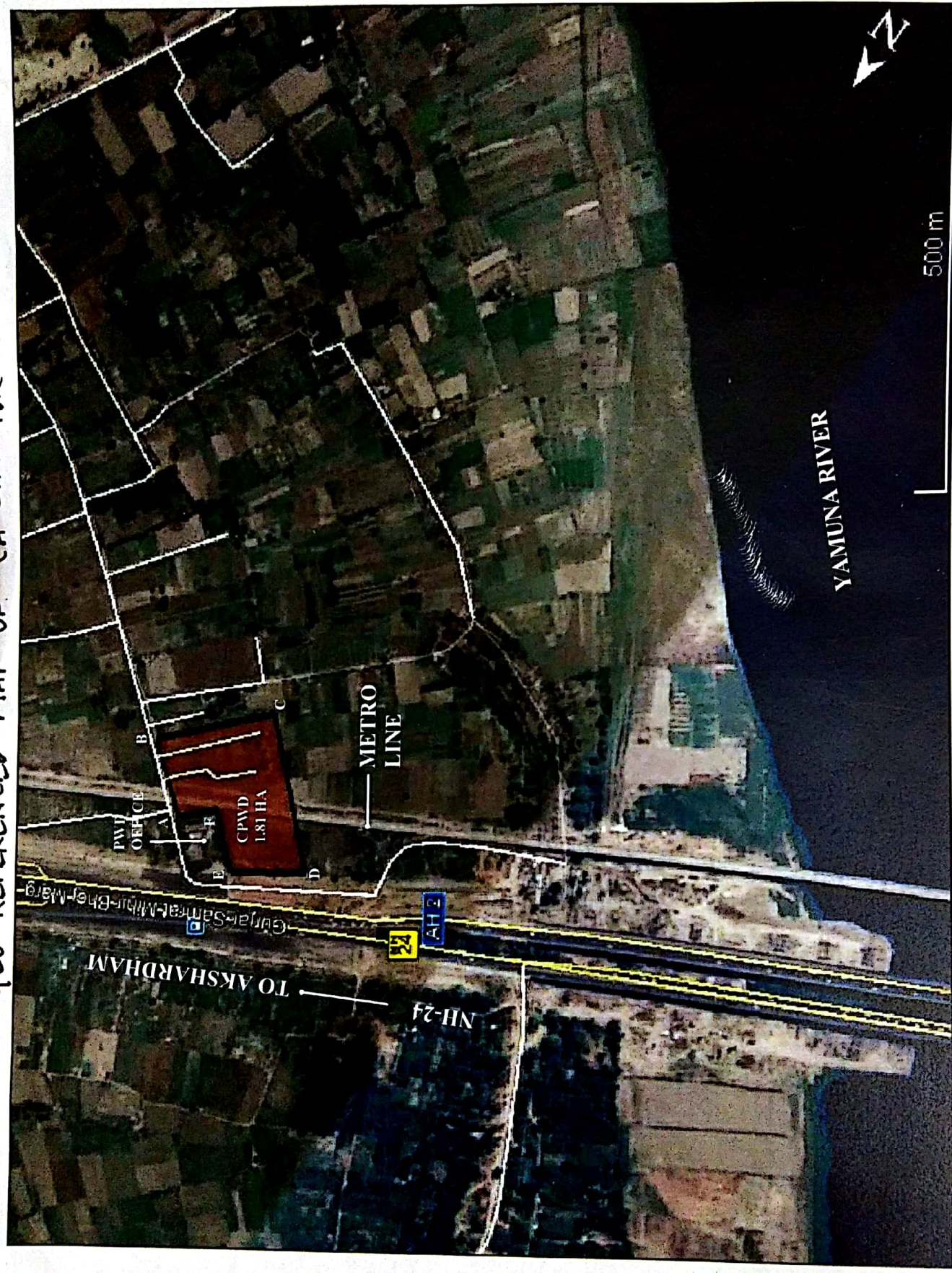
