उपर्युक्त विषय के संबंध में सूचित करना है कि भारत सरकार के प्रासंगिक पत्र द्वारा विषयगत परियोजना के संदर्भ में 07 बिन्दुओं पर पृच्छा की गई है, जिसकी उत्तर सामग्री निम्नवत् है:-

1	The instant proposal is for more than 100 Ha. Accordingly the State Government is requested to submit the Site Inspection Report of the Nodal Officer as per the provision of the Van (San Rakshan Evam Samvardhan) Adhinyam, 1980.	To be replied by Nodal Office.
2	As per the Para 10.4 of the Chapter-10 issued under the consolidated Handbook of Guidelines and clarifications issued under the Van (Snarakshan Evam Samvardhan) Rules-2023, it needs clarification whether the user agency has obtained NoC from various linear forest land owned agency. The copies of the same shall be submitted.	UA has submitted that NOC for Jungle Jhari Area has been obtained for all 3 District. Same has been uploaded in Additional Documents under Part-I.
3	Detailed violation report and the action taken by the State Forest Department to stop the work in the forest land needs submission. Further, the State Govt. shall submit the present status of court case/action taken against the Govt. official under 3A &3B of Van Adhinyam, 1980 indicating details chronology of the event for allowing use of forest land without permission.	As soon as violation in Ramgarh Forest Division part was detected and responsible officers and personnel were identified, complaint case no-46/2025 was filed on 15.01.2025 under provision of Indian Forest Act, 1927. Complete prosecution was sent to court on 08.09.2025. The case is in hearing stage. As per prosecution report, total of 0.12 ha of land was found broken for construction of towers. Field functionaries- Forest guard, Forester and Range officer, during the period when violation happened has retired before violation was detected via Google earth imagery. As violation in this division was over smaller area it can not be detected by current DFO in general oversight.

		The action under section 3A & 3B of Van Sanrakshan Adhiniyam, 1980 doesn't arise as neither forest official ever allowed any formal work nor any stage-I for the same project has been approved. Thus, no violation of Van Sanrakshan Adhiniyam, 1980 arises.
4	The DFO Ranchi in their Part-II reported that the forest area under violation as 0.25 ha and period of violation mentioned as 9.5 years further informed that the वनपाल/वनरक्षी द्वारा माह अगस्त, 2025 में ही वन वाद दर्ज किया गया है। Therefore, the reason behind such delayed action on the violation needs justification.	To be replied by DFO, Ranchi.
5	The DFO, Latehar Forest Division in Part-II of the proposal reported that the presence of rare/ endangered/unique species of flora and fauna found in the area. However, the details in this regard has not mentioned in the proposal. This needs justification	To be replied by DFO, Latehar.
6	The recommendation of CF, Daltonganj Circle has not been found uploaded on PARIVESH. The State Government shall upload the recommendation of CF, Daltonganj Circle on PARIVESH.	To be replied by CF, Daltonganj.
7	As per DSS analysis, following has been observed.	
7(i)	The KML file of forest land proposed for diversion is found 123.63 ha instead of 126.974 as per the proposal. Therefore, correct KML file of the proposed forest land shall be uploaded.	UA has submitted that some patches of KML file of diverted forest land under Ramgarh forest division was not visible due to some technical glitch. The glitch in KML has been removed. It has been re-uploaded in Part-I of the proposal.
7(ii)	It is observed that in the Ramgarh Forest Division, Total 29.41 ha degraded forest land have been proposed for CA but the KML file has been uploaded for an area of 13.39 ha. Therefore, complete KML file of the proposed CA land under Ramgarh Forest Division shall be uploaded on PARIVESH.	KML file for CA land (29.44 Ha) has been uploaded earlier on PARIVESH portal. Due to some technical glitch, it was only showing as 13.39 ha. Therefore, KML file for CA land is being uploaded again in PARIVESH portal and it is also provided in pen drive for easy assistance.
7(iii)	As per the DSS analysis the proposed CA land is having encroachment of Agriculture land and is one CA patch the plantation work is already visible. The State shall offer their comments in this regard.	The CA land was reviewed again. In patch of Koto village (3.82 Ha) some Soil Moisture Conservation work (contour/trench) was done 5 years back under Climate Change Adaptation Project. No plantation has been done on the patch. In patch of Daridih some agricultural activities are ongoing which will be taken under possession during plantation.
