This is with reference to the above proposal. The Conservator of Forests, West Circle Rajouri/DFO Nowshera/user agency have uploaded the requisite documents in Part-I and Part-II. The point wise detail is given as under



As reported by DFO Nowshera, non-forest area of 0.738 Ha of the link namely Sanki to Deoli was included in the forest segment area and same has now been rectified and the involvement of forest area has been changed from **6.79 Ha** to **6.051 Ha**. The number of trees remained the same, as trees were not involved in the non-forest area which was earlier included in the forest area.

As the forest area in this proposal has been reduced to **6.051 Ha**, the Administrative Department is requested that before forwarding to proposal to the IRO, MoEF&CC Jammu the revised recommendation (**Part-V**) may kindly be uploaded.


