The correct kml file has been uploaded in Parivesh portal for onward submission to Ministry of Env. Forest & Climate change for consideration of the proposal pl.

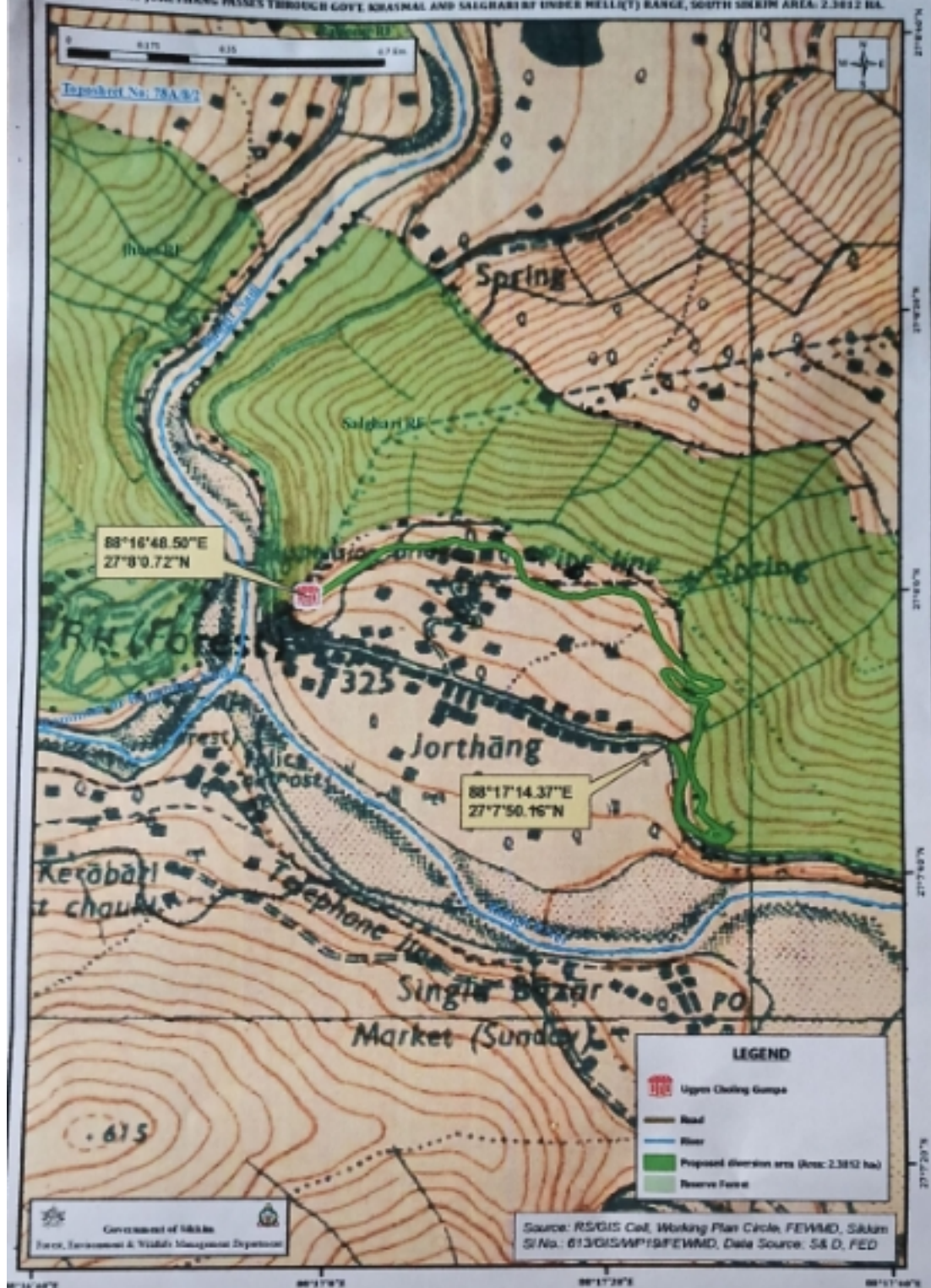
