- I am directed by the Govt. of Himachal Pradesh to enclose herewith a proposal for the diversion of 64.2016 ha of forest land, for the construction of North Campus Central University Dharamshala, Distt Kangra, State Himachal Pradesh, within the jurisdiction of Dharamshala Forest Division Distt Kangra, HP, for obtaining GoI approval under the provisions of the Forest (Conservation) Act, 1980.
- It is submitted that earlier a proposal for the diversion of 75.3931 ha of forest land for the construction of North Campus Central University Dharamshala, Distt Kangra, within the jurisdiction of Dharamshala Forest Division Distt Kangra, HP, was submitted to GoI vide this office letter dated 23.11.2020. GoI, MoEF & CC Jor Bagh Road-Aliganj, New Delhi vide its letter dated 8.3.2021, enclosing therein copy of site inspection report of APCCF, Integrated Regional Office Shimla and asked to submit the proposal as per observations /recommendations of the site inspection report of IRO Shimla. Accordingly, CCF Dharamshala has now submitted the revised proposal fulfilling all the observations/ recommendations of IRO Shimla.
- CA has now been proposed over total 128.5 ha of forest land in Dhar Narwan=22.5 ha, CFS Khanyara=75 ha, UP Lam I=31 ha in Dharamshala Forest Division.In the revised proposal, in all 7124 trees and saplings of different species are standing over the forest land proposed for diversion. Out of 7124 trees 2991 trees will be felled and 4133 trees will remain standing in the set back area as green cover.

5. As the proposal attracts the provisions of the Forest (Conservation) Act, 1980, the same is presented to you for consideration and approval please.
