Subject: **Diversion of 25.6 ha. of forest land in favour of HPPWD for the construction of Bhaba Mud Sagnam Attregoo road Kms. 0/0 to 44/400, within the jurisdiction of DFO Kinnaur and WL Sarahan Division Distt. Kinnaur and Shimla HP. (online No. FP/HP/Road/44357/2020).**

Please refer to your office Memo. No. 2150 dated 2/7/2022 & M-1/1165 dated 15-06-2-2022 on the subject cited above.

3. The following shortcomings have still not been attended which may be attended in all respect

Kinnaur Division:-

1. The detail of district wise area has been mentioned same which seems incorrect and required to be reviewed / corrected.
2. Against the column No. 1 (ix) of hard copy 'the proposed project is located in the forest land' has been mentioned whereas online Part-II, 1 KM has still been mentioned, necessary correction in this regard is required to be made.
3. The cost estimate for plantation portion for reclaiming the dumping area is still not been placed in proposal folders.
4. The scientific name of species is required to be mentioned in online, in case scientific name is not available in drop box, than, same is required to be mentioned in the column of local names in brackets.
5. Now CA scheme has been prepared for amounting of Rs. 4597432/- whereas amount of CA has been mentioned Rs. 3287019/- against the column No. 13 (I) (i) in online Part-II. Further, digital map has been uploaded in online Part-II instead of CA Scheme and toposheet and nothing has been uploaded against the column No. 13 (v) of online Part-II.
6. The villages to be benefitted are still not been mentioned in KML file.

WL Division Sarahan:-

1. The working plan prescription has still not been mentioned by DFO against the column 5 of online part-II. If there is no working plan the same may be mentioned against the column.
2. In reply to point No.3 necessary correction stated to have been made but against the column No. 1 (ix) 'the proposed project is located in the forest land' has still been mentioned whereas online 0.2 KM has been mentioned.

3. The CA area is still overlapping with the area of CA proposed by DFO Kinnaur in the instant proposal. Though different areas for CA has been proposed hence KML file is also required to be marked accordingly.
4. In reply of point No. 6, revised bill of NPV stated to have been prepared but density of vegetation as mentioned in online part-II is still incorrect as 43 trees are involved in the alignment, 0 density is not correct. Further, NPV bill as placed at page No. 23 is not correct as rates of very dense forest has been applied.
5. It has been noticed that most of the undertakings as placed in proposal folders the area of 20.7963 ha. has been mentioned whereas, 20.8 ha. area has been mentioned in online Part-I for WL Division Sarahan, due to which actual area can not be ascertained, hence **exact area may be shown in online Part-I & II** and all concerned documents as placed in proposal folders be prepared accordingly. As per the area mentioned in documents as placed at page No. 22 total area for diversion is 25.5963 has been mentioned. Hence, proposed are is required to be reviewed.
6. The documents as placed at page No. 85 to 95 are photocopy, attested/ authenticated copies may be placed instead.
7. The area of CA has been shown 41.6 in digital Map whereas CA has been proposed over 42.0 ha. area. Further the digital map of the CA is not matatching with the shape of KML file.
8. In reply to pint No. 7 needful stated to have been done whereas, 'No' has still mentioned in the column No. 8 (ii) of online Part-II.
9. The cost estimate for plantation portion for reclaiming the dumping area is still not been placed in proposal folders.


You are, therefore, requested to make proper scrutiny of the proposal folders and submit the requisite documents either in original or authenticated copies in it. However, the proposal folders as received with the memo are returned herewith for doing the needful.


