b-	Compensatory afforestation scheme is without accounting for rate enhancement due to increase in wage rate, inflation etc.	The CA scheme model has been made by accounting rate enhancement due to wage rate or inflation by committe under the chairmanship of PCCF (HoFF) Jaipur. The CA amount has been taken according to the model.
c-	Details regarding no. of seedings to be planted per has have also not been provided with the proposal.	700 plants per ha. will be planted and total of 5488 seedlings will be planted. Which is as per the model.
