Through the site it is shown as located in Bor Dikrai river as per SoI map, the river has shifted towards west and the land is already stabilized which can be seen in the latest satellite imagery vide letter No.FSET/A/7.971 NF Railway 132 KV/2023/344-345 dated 27.01.2023(copy enclosed)
Condition No(2)	The Principal Chief Conservator of Forests & Chief Wildlife Warden, Assam has submitted the comment of the proposed area as it falls in Sonitpur Elephant Reserve, vide letter No.WL/FG/Railway Electrical Construction/Sonitpur East dated 01.06.2023 (Copy enclosed)
