


SITE INSPECTION REPORT

As per direction of APCCF (Protection) & Nodal Officer FCA in EDS dated 12-3-2021, the undersigned inspected the forest land involved in the proposal of forest diversion subject "Diversion of 0.4707 ha. Forest land for laying of Optical fibre Cable along the Phalodi-Pokran Road (NH-11) from phalodi BSNL exchange to Beethadi gram under NOFN Project (chainage 0.00 to 14.040 Kms) The Phalodi jodhpur ." on 18-3-2021 along with DCF, Jodhpur. The requirement of forest land as proposed by the user agency is barest minimum required for the project. 
