

2	The new Sol Toposheet map with starting point and end point of the road with GPS coordinated is to be furnished.	The new Sol Toposheet map with starting point and end point of the road with GPS coordinated has been furnished.
3	As per the site inspection report submitted by the DFO, legal status of the proposed area is mentioned as KhamaI whereas in online under Part-II of Para 2, the proposed forest area is wrongly mentioned as Khesra Forest. Needs to rectify the area and legal status of the proposed diversion area.	The legal status of the proposed land is KhamaI and area is 0.10033 and the same has been uploaded in PARIVESH.
4	Total period of which the forest land is proposed is not mentioned in Part-I.	Total period of forest land proposed for diversion is till the life of the road.
5	As per the submitted FORM A (Part-I) employment has been categorized in Skilled labour and Unskilled Labour. Hence, both the categories come under temporary employment. Needs to rectify the actual employment figure in Part-I.	The concerned DFO(T) has been informed to submit the details as observed by the IRO. Reply is awaited.
6	The technically approved Compensatory Afforestation Scheme by the Competent Authority of the State Govt. is to be furnished.	The technically approved Compensatory Afforestation Scheme by the Competent Authority of the State Govt. has already been furnished and uploaded in PARIVESH.
7	Certificate from Chief Secretary of the State/UT for non-availability of non-forest land for Compensatory Afforestation is to be furnished.	Certificate from Chief Secretary of the State/UT for non-availability of non-forest land for Compensatory Afforestation has already been furnished.
8	Needs to upload "No trees felling certificate" duly signed by the concerned authorities.	No Tree Felling Certificate duly signed by the ACF(T), East Division is submitted and uploaded in PARIVESH.
