Sir,

Regarding the non uploading of the CA scheme, it has been uploaded now, and it has been also uploaded under the Additional document, along with the necessary remarks.

Further regarding the justification of the selection of 35 Ha(Forest and Non forest) CA land, the 20 Ha CA Govt Khas land which has been proposed to be mutated towards forest department has a good number of trees and has a density of over 60% along with other woody shrubs which may be undisturbed, and this 20 Ha of Govt Khas land can accommodate an additional 5000 seedlings through ANR(i.e 250 seedlings per Ha) to enrich the existing forest (as per decision support system tools and also other physical verification reports), so in order to accommodate the planting of the remaining 15000 seedlings, an additional land of 15 Ha has been chosen under Chandipur Mouja of Kanchancherra Forest Beat, where AR plantation can be carried out, with plantation of 1000 seedlings per ha area.

The project of **15 ha** is situated at **Chandipur** Mouja of Kanchancherra Forest Beat under Kanchanpur Forest Sub-Division, where there shall be AR plantation with 15000 seedlings to be planted, This area is a degraded area with less than 10% density of trees coverage.

It may be mentioned that the necessary inputs have also been included in the site suitability certificate uploaded under the Parivesh site.
